Mr Whiley: Organised by. And all subsequent visits have been directly between us and the Japanese team.

Senator CONROY: The sponsored organised visit by DMO—who did that involve?

Mr Whiley: There were numerous people. Again, I would need to—

Mr Whiley: There was David Gould, Greg Sammut and a number of other people inside DMO. **Senator CONROY:** So there was DMO. There was Admiral Sammut. He is part of the overall assessment group, is that right?

Senator CONROY: So he came with the Japanese delegation—

Mr Whiley: To ASC North, yes.

Senator CONROY: And he did not attend with the French and the Germans?

Mr Whiley: No.

Mr Whiley: On the initial introduction to ASC.

Senator CONROY: He was accompanied by numerous others—and I think you indicated Mr Gould
