

# **Immigration Detention and Community Statistics Summary**

31 January 2014



## About this report

This report provides an overview of the number of people in immigration detention and offshore processing centres as at midnight on the date of the report. The report is produced on a monthly basis.

Data is sourced from several departmental processing and recording systems. Data relating to the immigration detention population is dynamic and there can be delays in transmission of information from the department's immigration detention network operations. Variations in figures between this report and previous issues can occur. Due to these issues, data from the current financial year should always be considered provisional.

Note: Bridging Visa figures in this report only relate to illegal maritime arrivals.

The Department has initiated a data cleanse which has identified a systems error in how the status of IMA BVE holders is reported. Further work is currently being undertaken to resolve this issue.

# **Immigration Detention and Community Statistics Summary**

As at: 31 January 2014

There were 5867 people in immigration detention facilities and alternative places of detention, including 3967 in immigration detention on the mainland and 1900 in immigration detention on Christmas Island as at 31 January 2014.

Separately, 3391 people are living in the community after being approved for a residence determination and 22670 are living in the community after grant of a Bridging Visa E.

# **Community Population by State/Territory**

Of the 3391 people approved for a residence determination to live in the community, 42% are situated in Victoria, 19% in Queensland, 18% in New South Wales, 9% in South Australia, 9% in Western Australia, 2% in Tasmania and 1% in the Australian Capital Territory.



# Immigration Detention Population from 1990 to 31 January 2014

The number of people in immigration detention month to month continues to fluctuate, predominantly due to the changing pattern of unauthorised maritime arrivals. The numbers of illegal maritime arrivals in January 2014 were down 99% compared to the previous month.

Figure 1 - Population in Immigration Detention




#### **People in Immigration Detention by Arrival Type**

The number of people in immigration detention, who arrived unlawfully by air or boat as at 31 January 2014 was 8831, representing about 95% of the total immigration detention population.

There were also 427 people (about 5% of the total immigration population) who arrived in Australia lawfully and were subsequently taken into immigration detention for either over staying or breaching their visa conditions, resulting in visa cancellations.

# **People in Immigration Detention by Nationality**

Of the 5867 people in held immigration detention facilities and alternative places of detention as at 31 January 2014, around 38% were Iranian nationals, 16% were Sri Lankan nationals, 12% were Vietnamese nationals, 3% were Afghan nationals and 2% were Pakistani nationals.

Of the 3391 people living in the community after being approved for a residence determination, as at 31 January 2014, around 27% were Iranian nationals, 24% were Sri Lankan nationals, 17% were Afghan nationals and 7% were Iraqi nationals.



# **Children in Immigration Detention**

As at 31 January 2014, there were 1006 children (aged under 18 years) in immigration detention facilities and alternative places of detention.

The number of children in immigration detention facilities decreased in January as children completed mandatory processing and were transferred into the community or to an Offshore Processing Centre as part of a family group.

The number of children living in the community after being approved for a residence determination has slightly decreased in January 2014 to 1631 children.

Figure 4 - Children in the Community under a Residence Determination



# **Time in Held Immigration Detention**


Of the 5867 people in immigration detention facilities and alternative places of detention as at 31 January 2014 around 8% had been detained for 3 months or less and 93% had been detained for 12 months or less.

The average period of time for people held in detention facilities is steadily increasing at 226 days as at 31 January 2014, however remains lower than 277 days in November 2011.

# **Time in Community Detention**

Of the 3391 people in Community Detention as at 31 January 2014, less than 1% had been detained for 3 months or less and 28% had been detained for 12 months or less. This includes the period detained in facilities and/or alternative places of detention prior to transferring to community detention.
