Inquiry into the Social Services Legislation Amendment (Encouraging Self-sufficiency for Newly Arrived Migrants) Bill 2018

Senator WATT: Thanks. I realise this might be more a matter for the immigration department, but do you know on average how long migrants are waiting in Australia before they are granted a permanent visa?

Ms Davis: That's a matter for Home Affairs. We understand that around 50 per cent of their permanent visa grants are made for people onshore. As to the waiting time, that's something for Home Affairs.

Answer:

Processing times vary from month to month and are impacted by a range of factors including the completeness of the application, how promptly applicants respond to any additional information requests from the Department of Home Affairs and the complexity of assessments not limited to but including health, character and national security requirements. In addition, the annual Migration Program that is set by Government places a ceiling on the number of permanent visas that can be finalised in each program year.

Processing times are calculated on the time it takes for all applications in a subclass to be finalised in the previous month at the 75th and 90th percentile points. This means two processing times are displayed, indicating how long it took to finalise both 75 and 90 per cent of applications submitted globally. The website is updated each month providing an indicative timeframe for processing applications.

The table provided at [Attachment A](#) details published processing times for permanent visas as at 28 February 2018. Reporting on processing times does not currently differentiate between applicants that apply offshore and those that apply in Australia.
