Executive Briefing

Industrial Hemp as a Catalyst for Regional Economic Revitalisation

Purpose

To advocate for strategic investment and supportive policy to unlock the transformative potential of industrial hemp for regional Australian communities.

Overview

Industrial hemp is a low-THC variety of *Cannabis sativa* cultivated for non-psychoactive uses across food, textiles, construction, biofuels, and more. Its broad utility and environmental benefits position it as a key growth industry for Australia, with the global market forecast to exceed USD \$26.6 billion by 2025.

Key Opportunity

Regional Australia faces economic challenges from reliance on single industries, population decline, and climate-related pressures. Industrial hemp presents a unique opportunity to:

- Diversify agricultural outputs
- Create jobs and stimulate new industries
- Enhance environmental outcomes
- Support community wellbeing through sustainable housing and nutrition

Strategic Priorities

1. Policy and Regulation

- Develop a *National Industrial Hemp Strategy* to ensure consistency in licensing, THC limits, and regulatory settings
- Approve the use of hemp in animal feed and integrate into carbon credit schemes
- Remove barriers to full-plant utilisation to support innovation and competitiveness

2. Investment and Infrastructure

- Fund development of regional processing and manufacturing hubs (e.g., decortication, hempcrete, food processing)
- Offer low-interest loans, grants, and tax incentives for hemp-related businesses
- Facilitate *public-private partnerships* to de-risk early investment

3. Research and Development

- Advance regionally-appropriate seed varieties and cultivation methods
- Innovate high-value hemp products (bioplastics, textiles, building materials)
- Expand trials in phytoremediation and soil regeneration

4. Community and Industry Engagement

- Support formation of regional hemp cooperatives and clusters
- Launch awareness campaigns to destigmatise and educate on hemp's benefits
- Fund *skills development programs* tailored to farming, processing, and manufacturing
