- e. Who approved the exemption (i.e. Finance Minister; Prime Minister)

Response

Details of the seven approved ASL exemption requests for announced decisions are provided in Table 1 below.

Under the Budget Process Operational Rules, all formal ASL exemption requests for items brought forward for Cabinet consideration must be first directed to, and approved by, the Minister for Finance, as part of the full deliberative process of the Expenditure Review Committee of Cabinet.

The Government considers a number of proposals in the context of developing the Budget and MYEFO, and the recent Economic and Fiscal Update July 2020 (2020 EFU). Information on proposals that may not have been agreed, proposals agreed as Decisions Taken But Not Yet Announced, or proposals to be announced in the 2020-21 Budget are not disclosed as it would reveal Cabinet-in-Confidence deliberations.

How many ASL Offset Rule exemption applications have been made in total since the 2019-20 Budget round

Response

Since the 2019-20 Budget, 11 ASL offset exemption requests were made under the ASL Offset Rule (Rule 4.3 of the Budget Process Operational Rules refers) for proposals considered in the 2019-20 MYEFO and Economic and Fiscal Update July 2020. Four of these requests did not progress for consideration as the requesting Minister withdrew the request or the request was superseded by a Government decision.

ASL offset exemption requests made for proposals in the 2020-21 Budget context (other than those announced in the *Economic and Fiscal Update July 2020*) have not been included as the 2020-21 Budget is not yet finalised.
