RE: Productivity in Australia – Grain Industry Perspective

Dear Senators,

Executive Summary

The Australian grain¹ industry is one of the nation's most productive and trade-exposed agricultural sectors, exporting over 70 per cent of production in an average season and forecast to contribute 23.1 billion in export value in the 2025-26 season. (ABARES, 2025). Grain Trade Australia (GTA), as the peak post-farm gate industry body, welcomes the opportunity to respond to the Senate Select Committee on Productivity in Australia discussion paper.

Recent production growth in the grain sector has been driven by innovation, scale, and supply chain efficiency. Future productivity gains will increasingly depend on access to:

- **innovation,**
- **efficient regulation,**
- **coordinated policy,**
- **technology adoption,**
- **infrastructure performance, and**
- **access to open, rules-based global markets.**

This submission responds directly to the Committee's focus on:

- a) Economy-wide productivity constraints
- b) The role of regulation and competition
- c) Infrastructure and supply chain performance
- d) Technology diffusion and innovation
- e) Policy coordination and institutional effectiveness

GTA submits there is opportunity to increase productivity in post-farm gate supply chains which will not only be beneficial for the grain industry, but also to other sectors (including meat, pork, poultry, food processing, beverages) that are dependent on the grain industry as an input, and the broader Australian economy. Regulatory misalignment and incoherence, infrastructure inefficiencies, trade friction, and market distortions – particularly in ports, coastal shipping, and container logistics – are eroding productivity gains achieved in the sector.

The submission sets out practical, evidence-based recommendations that align with the Committee's discussion paper and support measurable productivity improvements across agriculture and

downstream sectors. This supports GTA’s policy stance and builds on its 10th of November 2025 letter to Minister Collins and through contribution at the DAFF Productivity Roundtable in August 2025.

1. Introduction and Context

Grain Trade Australia (GTA) welcomes the opportunity to provide input into the Senate Select Committee on Productivity in Australia. This submission draws on GTA’s extensive engagement with government, regulators, and international institutions and reflects long-standing and consistent positions on productivity, trade facilitation, and supply chain efficiency.


Productivity in agriculture – and particularly in export-oriented sectors such as grain – is increasingly shaped by **system-wide performance** rather than individual farm or firm behaviour. While farm-level productivity remains strong, post-farm gate constraints are counterproductive to national productivity outcomes.

This submission highlights the importance of:

- Aligning government policy with industry-led productivity initiatives and strategies
- Supporting industry driven self-regulatory frameworks to reduce red tape and compliance costs
- Investing in supply chain efficiency, infrastructure, and technology
- Ensuring open, fair, and predictable access to international markets
- Embedding sustainability policies that support, rather than distort, trade and productivity

GTA believes there needs to be a comprehensive and consistent strategy across the industry to support productivity outcomes. This approach is shown in figure 1.

2. The Grain Sector and National Productivity

The Australian grain sector is one of Australia’s largest agricultural industries, exporting over 70 per cent of production in a normal season. In 2025/26, grain production is forecast to total approximately **70.5 million tonnes**, with exports of **48.8 million tonnes**, valued at **\$22.8 billion** (ABARES, 2025).

The grain industry:

- Is an important contributor to economic growth and resilience for rural and regional Australia, and to Australia’s export income

- Underpins other key agricultural and manufacturing sectors, including meat, livestock, pork, poultry, brewing, food processing, and aquaculture.
- Is a critical contributor to food security and economic stability in the Asia-Pacific region; and
- Operates in highly competitive, price-taking global markets

As global population growth and rising incomes increase demand for food, productivity growth — rather than expansion of resource use — will be essential. The United Nations Food & Agriculture Organisation (FAO) estimates global food production must increase by **50 per cent by 2050 than it produced in 2012**, (FAO, 2021).

Australia's ability to meet this demand competitively depends on **efficient supply chains and conducive policy settings**, to support on-farm- innovation.

3. About Grain Trade Australia

GTA is the leading post-farm gate industry association in the Australian grain sector, representing over 295 member organisations (see attachment) across trading, storage, handling, processing, and logistics.

GTA's core purpose is to **facilitate efficient, transparent, and competitive grain trade**, domestically and internationally. This is achieved through:

- An industry-managed framework including the **Grain Industry Code of Practice**, endorsed by the Department of Agriculture, Fisheries and Forestry (DAFF)
- Dispute Resolution services and supply chain assurance frameworks
- Trade and market access advocacy
- International engagement through the **International Grain Trade Coalition (IGTC)**, where GTA currently holds the Presidency.

GTA's role is directly aligned with the Committee's focus on institutional effectiveness, regulatory efficiency, and productivity-enhancing governance.

4. Supply Chains as the Primary Productivity Lever

The Committee's discussion paper highlights infrastructure, regulation, and coordination failures as key contributors to Australia's productivity slowdown. GTA strongly agrees.

For the grain sector, **supply chain performance is now a dominant productivity constraint**. Every inefficiency adds cost to a low-margin, high-volume industry and reduces competitiveness in global markets.

GTA's **Modernising the Grain Supply Chain Strategy** identifies four productivity growth pillars:

1. Skills and capability
2. Quality and market access
3. Technology adoption
4. Transport and logistics

Improvements in supply chain efficiency add value to **every tonne of grain**, delivering compounding productivity benefits across agriculture and downstream sectors.

5. Policy and Regulatory Opportunities to Lift Productivity

5.1 Industry–Government Policy Alignment

Productivity outcomes are strongest where government policy supports and aligns with industry-driven strategies. GTA's collaboration with DAFF on the **Grain Storage Assets and Management Standard (GSAMS)** is a practical example. GSAMS is an innovative and collaborative project between DAFF and GTA under which DAFF recognises the application of GTA's Australian Grain

Industry Code of Practice aligns with DAFF’s regulatory requirements. This alignment enables streamlining of regulatory and industry quality assurance practices.

GSAMS:

- Improves compliance consistency
- Reduces regulatory intervention through assured systems
- Lowers transaction costs for both industry and government
- Reduces duplication and repetition in audit, compliance and quality assurance processes.


Ongoing and further government support for GSAMS adoption would directly lift supply chain productivity and regulatory efficiency.

5.2 Self-Regulation and Competition

The DAFF review of the **Port Terminal (Bulk Wheat) Code of Conduct** highlights the productivity benefits of self-regulation:

- In 2008 when the “Single Desk” for wheat exports was removed there were 17 port terminals operated by 4 PTSPs.
- In 2024, there are 32 port terminals, operated by 18 PTSPs,
- a consequential increase in annual **export capacity from around 2 million tonnes in the early 2000’s to almost 6 million tonnes in 2022-23.**

This expansion reflects capital investment, innovation, and increased competition as core drivers of productivity (DAFF, 2024).

To further streamline industry process, GTA is developing an industry Port Protocol with the view to seeking the Government’s support for this to replace the current Port Terminal Access (Bulk Wheat) Code of Conduct which will further strengthen the self-regulatory framework, and industry driven productivity growth.

5.3 Technology Adoption and Digital Trade

Technology diffusion is a central theme in the Committee’s discussion paper which is supported by GTA. Government plays a critical role in the efficiency of international trade. We note digitalisation of **trade documentation for export grain** is an opportunity to reduce regulatory burden and significantly improve efficiency for the industry.

Industry is seeking the rapid deployment of ePhyto within the Australian system, with current limited implementation by DAFF putting the Australian industry at a **competitive disadvantage**. The grain industry globally has identified a number of other opportunities for digitalisation of documentation to follow e-Phyto.

5.4 Trade and Market Access

Open, rules-based trade is fundamental to productivity in export sectors. The proliferation of **non-tariff measures (NTMs)** increases compliance costs, distorts markets, and reduces productivity.

Through the International Grain Trade Coalition (IGTC), GTA advocates for risk and science-based approach at global forums including:

- World Trade Organisation (WTO)
- Codex Alimentarius (Codex)
- International Plant Protection Convention (IPPC)
- UN Food and Agriculture Organisation (FAO)
- International Grains Council (IGC)

Trade policy coherence globally is essential to maintaining productivity growth.

Additionally, addressing existing trade barriers for Australian grains and modernising free trade agreements (FTAs) is essential to ensure that the grains industry can continue access markets to support productivity growth. This will require a multi-pronged approach by the Government focused on improved market access, improved pathways for addressing NTMs and prevention of future NTMs.

Although existing FTAs provide preferential tariff access, modernisation is needed to ensure FTAs reflect contemporary supply chains, technology and biosecurity needs. Activities to deliver enhanced outcomes for the Australian grains industry include ensuring effective implementation of existing FTAs, addressing NTMs and trade barriers, continuing to negotiate new FTAs and establishing a trade facilitative environment through modernisation of FTAs. GTA has provided a comprehensive set of recommendations to the Government across these issues as part of the southeast Asia modernisation review.

6. Supply Chain Productivity Constraints

6.1 Container Port Charges

Australia's ports are critical assets and require a concerted industry and government focus to ensure efficiency is maximised. Container stevedore's terminal service **fees applied to landside services are threatening to impact access to valuable international markets** that are serviced through the container supply chain. This is likely to have a consequential impact on:

- the level of competition in the Australian grain supply chain

employment in rural and regional communities.

Landside container terminal charges disproportionately impact low-value, high-volume exports such as grain. Flat per-container fees distort competition and represent inefficient cost allocation.

This misalignment reduces containerised grain exports and undermines supply chain productivity and consequently reduce the shipment of grain in containers.

Indiscriminate allocation of costs, without regard for where costs are incurred is a fundamental breach of basic economic principles of the efficient allocation of resources. These **costs should be apportioned based on where they are incurred**, so as not to exacerbate economic distortions and inefficiencies.

From GTA's perspective, fees and charges, including landside fees, should in principle align with commercial contracting arrangements across the supply chain, ensuring those who pay the fees can negotiate service productivity. This is currently not the case with grain container exports. GTA's members who export grain should be able to contract directly with shipping lines for services, and shipping lines should then negotiate and contract landside services with stevedores and container parks, as they can apply commercial and operational pressure to ensure efficiency.

Pricing should be determined through negotiation by parties who can influence service levels and productivity outcomes, rather than being imposed as non-contestable costs on exporters. This will lead to a more efficient and productive sector.

This issue warrants the immediate attention of the committee and Government.

6.2 Coastal Shipping Reform

Proposed reforms to coastal shipping licensing would reduce flexibility and increase costs. During the 2017–19 drought, temporary licensing arrangements enabled the movement of over **6 million tonnes of grain** to the east coast.

Restrictive licensing would materially reduce productivity and resilience.

In GTA's submission to the Department of Transport *Independent Review of the Coastal Trading Act – Phase 2 Consultation* GTA noted particular concerns with proposed coastal shipping reforms including:

- Trade requires, (and functions best when there is) regulatory certainty and simplification for business and its processes. GTA's position has always been that an efficient supply chain is based on reducing cost, complexity, and the burden of un-necessary regulation.
- The grain trade will look to move grain interstate based on market signals, predominantly as a reaction to a severe drought in the eastern states where domestic demand for grain is the strongest. The requirement for transshipment due to drought occurs irregularly, particularly via coastal shipping. These movements will not occur until the market prices supports the additional cost of the freight and logistical costs associated with transshipment.
- The coastal shipping reforms proposed by the Government around licencing on a vessel-by-vessel basis, by the shipowner/charterer, rather than cargo owner are totally impractical and will either increase cost of transshipment of grain or stop it altogether.

6.3 Land Freight Infrastructure

Road and rail infrastructure constraints directly limit throughput and increase costs. Productivity improvements require:

- Coordinated national freight planning
- Harmonised regulation across jurisdictions
- Improvement to “below rail” (i.e. Government owned) infrastructure to increase efficiency. For example, “weak links” such as poor bridges, or track that can only support low axle weights impact efficiency on a whole rail line. Rail movements are constrained by the weakest point in the overall rail route.

6.4 Regulatory Alignment (Phosphine WELs)

Regulatory direction and change must be sympathetic to the practicalities of industry. Safe Work Australia (SWA) are proposing changes for the Workplace Exposure Limits (WEL) for the fumigant Phosphine to take effect from 1 December 2026. Phosphine is a common fumigation treatment used in the grain industry to protect grain quality and treat insect infestation.

SWA has recently changed its framework for Workplace Exposure Standards (WES), and for its own efficiency reasons have streamlined the methodology to review and update the WES. Under the old methodology it takes approximately \$825,000 and 2.5 years for government to update a single workplace exposure standard.

The new methodology is a broad approach that seeks to leverage existing sources of information for setting workplace exposure limits (WEL) and is expected to make wholesale (278) changes to WELs. There appears to be no individualized risk and feasibility analyses for each substance.

Phosphine, noted as a commonly used grain fumigation treatment has had its WELs drastically

lowered. While worker safety is a key principle of the grain industry, we question the evidence and the process utilised that resulted in the reduction in the WEL. This will have a dramatic impact on the efficiency of the grain industry supply chain.

Failure to have in place cost-effective and practical solutions for the industry to meet new SWA regulations by 1 December 2026 has the potential to negatively impact not only the availability of phosphine for use by industry but also will damage the excellent reputation the grain industry has in managing chemical compliance. The cost is likely to be significantly more to industry and the economy than the \$825,000 SWA is said to be seeking to save.

GTA seeks the committee’s support for a review of the SWA decision and as a minimum an extension beyond the 1 December 2026 implementation date to allow further engagement and discussion and a proper proportionate risk and evidence-based approach to be undertaken.

6.5 Enabling New Markets – Low Carbon Liquid Fuels

Low Carbon Liquid Fuels (LCLF) present an opportunity to create new domestic demand for grain, improving the energy sector resilience and value-adding to the Australian economy. The opportunity exists to develop a sustainable, export-aligned LCLF industry in Australia underpinned by reliable, scalable and certified oilseed feedstocks

The domestic oilseed crushing sector is expanding and these investments should be supported through **clear policy settings and demand signals** that incentivise long-term local processing and biorefining.

Policy settings must ensure:

- Market neutrality; and
- Efficient supply chain integration

GTA encourages the Committee and Government to consider a principled, flexible and market-aware approach to policy design to support LCLF production. Consideration of the full supply chain and emerging technologies will be critical to maximising the Program’s long-term value and effectiveness.

7. Recommendations

GTA recommends that the Committee:

Sound Policy principles & Settings

- a) **Support industry-led self-regulatory frameworks** to reduce red tape and compliance burden
- b) **Regulatory direction and change** must be sympathetic to the practicalities of industry
- c) **Strengthen trade and market access policy coherence, to address/prevent trade barriers**
- d) **Review of the Safe Work Australia proposed changes to the grain fumigant Phosphine** workplace reforms, which has significant potential to impact the Australian grain supply chain.

Supply Chain Efficiency

- a) Ensure **coastal shipping reforms enhance, not restrict**, supply chain flexibility
- b) **Improve port and container pricing transparency** to remove productivity-distorting charges, and recommend the price model connecting pricing with commercial contracts to enable contractual parties to commercially negotiate services and productivity

- c) Development of a **land freight policy** and strategy to improve road and rail networks and regulations (including cross jurisdictional regulations)
 - d) **Accelerate trade digitalisation**, including full implementation of ePhyto
 - e) **Support infrastructure investment and regulatory harmonisation** across road and rail freight

Leverage Opportunities

- f) **Align sustainability policy with productivity and trade principles** to enable new/expanded opportunities including LCLF.
 - g) In partnership with industry, continuing Australia's global **leadership in advocating** for the multi-lateral rules based global trade system

Areas of concern requiring the **immediate focus of this Committee** include:

1. Landside **container terminal charges**
2. Safe Work Australia revised **Workplace Exposure Limits for phosphine**, and
3. Progressing Government policy to support the **development of the LCLF sector**.

8. Conclusion

The Australian grain industry offers a clear case study of how productivity gains can be unlocked through better policy alignment, efficient regulation, and competitive supply chains.

GTA welcomes ongoing engagement with the Committee and stands ready to provide further evidence and practical insight to support its inquiry.
