Senator AYRES: Can you tell me on what date drafting instructions were first issued for the bill?

Ms Steel: I don't know if I've got the date for the drafting instructions to hand. We did engage with the Office of Parliamentary Counsel from November to January to help research and identify the references in legislation, and, from about mid-February, we did work with legislation liaison officers in a range of departments. I believe the drafting largely occurred in February and March, but the specific date when we formally asked for the drafting I might need to take on notice, or I can try to get an answer very quickly from colleagues for you.

Senator AYRES: We'll wait for your answer of course, but is it fair to infer from that that it's somewhere in that November-to-January period that the drafting instructions would have first been issued?

Ms Steel: It might have been informal at that stage. I'll just have to check if that was when we formally asked for drafting instructions.

Senator AYRES: But at the very latest it would have been February?

Ms Steel: At the latest, February; that's correct.

Senator AYRES: Did those drafting instructions include instructions relating to national cabinet that are reflected in schedule 3 of the bill?

Ms Steel: I believe we initially worked through the COAG legislative amendments; schedule 3 was slightly separate in terms of the process.

Senator AYRES: Yes. On what date were drafting instructions in relation to schedule 3 issued?

Mr Reid: I'm not sure that I have the precise date of that. I will try and get it for you while we're in the hearing.

Senator PATRICK: Was it before or after the decision?

Senator AYRES: Thank you, Senator Patrick. I always take a bit longer to get to my punchlines. It's just my long country drawl, really. I want to know whether it was before or after the decision in Senator Patrick's matter.

Mr Reid: I understand, Senator. I'll get that for you.

Answer:

Drafting instructions for Schedules 1 and 2 were issued on 17 February 2021. These instructions related to COAG and COAG Council amendments only.

Drafting instructions for Schedule 3 were issued on 25 February 2021.
