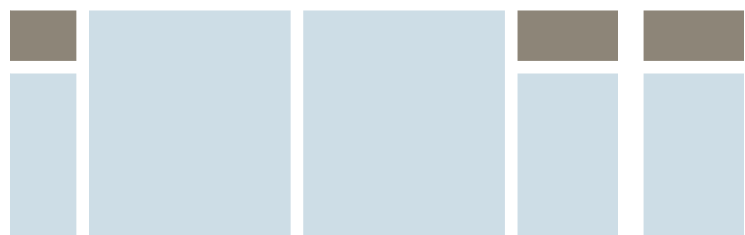


# Strategic Forum

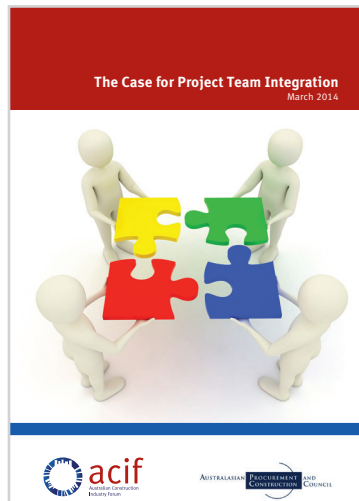

**A Guide to Project Initiation** shows that use of rigorous information analysis at the beginning of a project has the greatest potential to significantly improve the whole project.

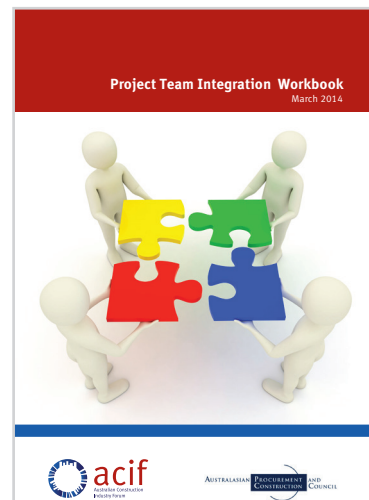
To achieve the most efficient and effective delivery of services from capital works assets, all parts of the building and construction industry need to continually review and improve how community expectations are best met. This Guide sets out a framework of leading practice methods for achieving this.



**The Case for Project Team Integration.** Integrating project teams to create, sustain and encourage collaborative behaviour is vital to improving efficiency and productivity, reducing wasted effort, and minimising disputes. The greater the level of project team integration, the greater the team's ability to collaborate on the design, cost plan and allocation of risk before construction begins.

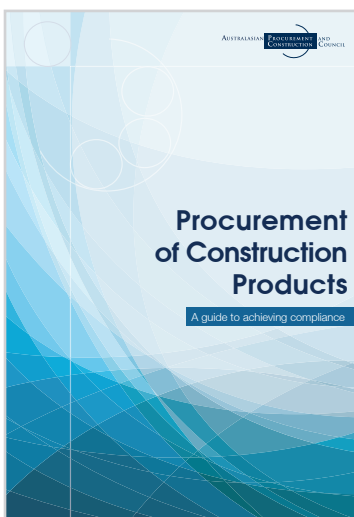
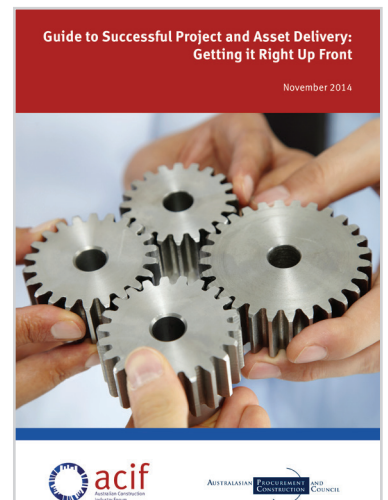
Everyone involved in the project team should have a shared interest in achieving the client's declared objectives.

**Project Team Integration Workbook** provides a checklist for project sponsors, designers and constructors to assess the degree to which they are able to integrate a project team, and identifies issues that need to be addressed to deliver optimal project outcomes. The focus is on the behaviours needed to ensure the project team works collaboratively and efficiently, with each member respecting the contribution of other members.

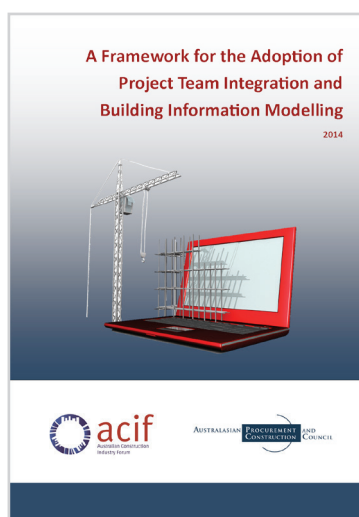


**Guide to Successful Project and Asset Delivery** describes the processes involved in planning, designing, and constructing capital works assets, and some of the existing resources produced by ACIF and APCC available to inform those processes.

It provides those who may be unfamiliar with how those assets are created with an introduction, and links to further information. It has a considerable focus on collaborative working, and the integration of project teams.



**Procurement of Construction Products: A guide to achieving compliance.** For the building and construction industry, the compliance and durability of construction products are major risk factors which need to be managed as they impact significantly on the service life and quality of building and infrastructure assets. This Guide seeks to assist in the decision-making processes for the procurement of construction products by elevating levels of compliance.



**A Framework for the Adoption of Project Team Integration and Building Information Modelling** is designed to guide and assist industry stakeholders in the adoption and implementation of Project Team Integration (PTI) and Building Information Modelling (BIM).
