### Parliamentary inquiry into a better family law system to support and protect those affected by family violence

## Final public hearing on family violence and the family law system

The [Parliamentary Inquiry into a better family law system to support and protect those affected by family violence](#) will hold what is expected to be its final public hearing on Tuesday. So far, the Committee has held 10 public hearings in Canberra and interstate. This week, the Committee will be hearing from academics with an interest in parenting matters and the capacity of family report writers. The Committee will also hear from the organisation Parents Beyond Breakup.

The Chair of the Committee, [Sarah Henderson MP](#), said “Throughout this inquiry, the Committee has held 10 public hearings, both in Canberra and interstate. We have conducted site inspections and spoken to people who have been affected by family violence and who have had to navigate the family law system. We have also heard about the role of family report writers in the family law system, and we look forward to exploring that further at this week’s hearing.”

This week’s public hearing is expected to be the inquiry’s last. Ms Henderson said, “The Committee has been carefully considering the evidence we have received throughout the inquiry, including the countless personal stories relayed to us by individuals both in person and through the 5,490 responses to the Committee’s online questionnaire. We thank all those who have taken the time to assist us with this inquiry. Over the coming months we will be formulating our report to the Parliament, which will contain recommendations to the Government.”
