COMMUNITY CONSULTATION REPORT FOR THE AIR5428-1 PILOT TRAINING SYSTEM FACILITIES PROJECT

This letter is to inform the Parliamentary Standing Committee on Public Works (PWC) of the nature and extent of community consultation undertaken as part of the AIR5428-1 Pilot Training System (PTS) Facilities Project (the Project).

The Project proposes to deliver works at five Royal Australian Air Force (RAAF) Bases including: RAAF East Sale in Victoria, RAAF Pearce and RAAF Gingin in Western Australia, RAAF Edinburgh in South Australia, and RAAF Williamtown in New South Wales.

Broadly, the strategy for community consultation adopted by Defence was undertaken with the objectives of:

- ensuring that the Community are informed about the project using effective and proven communication channels; and
- providing opportunities to the Community to raise issues and concerns about the Project that could be addressed by Defence as part of this Project.

Multiple consultation activities were undertaken as follows:

- provision of a project specific website hosted by Defence www.defence.gov.au/id/Air5428);
- a Key Stakeholder Briefing Program with State and Federal members, with individual briefings conducted where requested. Annex A provides details on the members consulted with a short description of the methodology and outcomes;
- a flyer (as detailed at annex B) was mail box dropped to some 7000 properties and main street shops in Sale;
- advertisements about consultation sessions in local newspapers and media as shown at annex C; and
- public information sessions near RAAF East Sale and Pearce outlined in annex D.

Two public information sessions were conducted on 23 and 24 March 2016, with the first session conducted in Sale, Victoria, at the Wellington Entertainment Centre. This session was advertised in the East Gippsland News on 23 March 2016 and online via the PTS Facilities Project website. There were approximately 60 members of the public who attended this information session.

The second public information session was targeted in Western Australia for the residents surrounding RAAF Pearce and RAAF Gingin. This session was held at Lowry Park Hall, Bullsbrook, Western Australia and was advertised in the Midland/Kalamunda Reporter and The Advocate on 22 and 23 March 2016 respectively. Online advertising was also secured on the Echo News website and information was available via the PTS Facilities Project website. There were four attendees at this session.

A table summarising the key issues and concerns is provided at annex D, including how Defence has or proposes to address them. Feedback regarding the Project was positive with strong support from the local community especially in the Sale region, where the majority of the works are planned. Of particular note was the interest from the local industry in terms of local employment opportunities in the Region.

In conclusion, no significant issues have been identified during Defence's community consultation that will impact on the proposed works, and Defence is satisfied that all reasonable steps to inform the Community about the Project and to provide opportunities for the Community to raise concerns.
