For the period March 2017 to November 2019, Services Australia estimates that there were approximately 45,000 decisions made by the Social Services and Child Support Division of the Administrative Appeals Tribunal that name the Chief Executive Centrelink or the Child Support Registrar as a party.

The collection of information needed to respond would require an unreasonable diversion of agency resources as each of the decisions would need to be manually retrieved from multiple databases, then individually reviewed.
