Dear Senators

***RE: Inquiry into the number of women in Australia
who have had transvaginal mesh implants and related matters***

Subsequent to my submission and presentation to the inquiry on Tuesday (19 September 2017), yesterday I received the attached invitation to a company sponsored invitation in the mail. This invitation speaks to concerns I raised regarding sponsoring company's organizing educational activities for Specialists and General Practitioners. As stated in the submission, these 'educational activities' seek to change:

- 1) prescribing patterns in favor of the endorsed product, and
- 2) seek to change the referral patterns to company endorsed 'experts'.

These activities occur with both medications and devices, are largely unregulated, and were at the heart of the problem of the over enthusiastic early utilization of the transvaginal mesh products.

Recommendations from your committee surrounding educational activities, company sponsorships and conflicts of interest would decrease the risk of the problem surrounding transvaginal meshes occurring again.
