#### **Dear Senator Bushby**

## Correction about consultations on the abolition of the Australian Charities and Not-for-profits Commission (ACNC)

We refer to the Senate Economics Legislation Committee's (**the Committee's**) Public Hearing on Friday 23 May 2014 for the Inquiry into the Australian Charities and Not-for-profits Commission (Repeal) (No. 1) Bill 2014.

We understand that at the hearing, the Committee was referred by a Department of Social Services (**DSS**) representative to a list of organisations that had been 'consulted' by the DSS on the abolition of the ACNC. The list referred to was one that had been tendered to Senate Estimates (refer to Senate Community Affairs Committee, Answers to estimates questions on notice; Question No: 334; **see Attachment A**).

We were surprised and concerned to see the name of our organisation, Justice Connect, on a list of 'organisations DSS had consulted about the ACNC'.

We understand that we were listed by the DSS because a representative from our organisation attended a Melbourne Law School event on the future of charity regulation, which was also attended by DSS representatives and Minister Andrews' adviser.

At that event we asked the DSS representatives whether consultation on the future of the ACNC was going to occur. We referred in particular to our December 2013 letter to the Minister and the Acting Secretary DSS, in which we requested to be included in any consultations about the ACNC, and the reply letter confirming that public consultations would be commencing in late January or early February 2014. In response to our question, the DSS representative advised that the Government had decided not to proceed with public consultations with the sector. They advised that the Minister was going to undertake targeted consultations only. We have not been contacted by the DSS or the Minister's office since that time.

We therefore request that the record be corrected to indicate that we have not been consulted, despite specifically requesting this opportunity. We note that the brief interaction we had with DSS representatives at an event at which they confirmed we would not be consulted is clear evidence of this.

As noted in our submission to your inquiry (Submission No. 113), the lack of consultation on the future of charity regulation in Australia appears to be contrary to the Government's own 'cutting red tape' guidelines:

The Government's own, recently released *Australian Government Guide to Regulation*<sup>1</sup> sets out that:

- full public consultation should be the default form of consultation to encourage "openness and trust in a decision making process" and
- targeted consultation should only be used when "your stakeholder group is in a small geographic area or other well defined category". 2

As charities are located Australia-wide and are not a small or homogenous stakeholder group, the consultation process for the ACNC Repeal Bill No. 1 falls well short of the Government's own, recently published guidelines.

Please note that we have also written to DSS to ask that our name be removed from the list of organisations.

For your reference, every year our Not-for-profit Law service provides legal help to thousands of small charities and not-for-profits across Victoria and NSW. Our service provides free and low-cost legal information, training, phone advice and pro bono referrals to help charities and not-for-profits resolve their legal and regulatory issues. We do this via a small group of dedicated charity lawyers, as well as drawing on the pro bono resources of the legal profession in both states, including many of the midtier, national and international law firms and the Victorian and NSW Bar, who are our members. We have also been writing policy submissions on not-for-profit regulatory issues for many years. Given our experience in this area, we were disappointed not to be consulted about the future of the ACNC and charity regulation in Australia.
