These destructive projects have not sought proper and informed consent from Traditional owners and would contaminate land, water and culture across the NT.</p> <p>There were no process of informed consent for the Beetaloo exploration to occur; no scientific explanation for the work; no translators provided to their community groups; and no information about the long-term impact and risks to water tables, their livelihood and the land on which they live. They're concerned that even the mining corporations involved (like Empire, Santos, and Origin) have not been able to tell them where the exploration wells will be, how they will impact the underground water, what the final production level mine would look like, or how many wells are being proposed. These Owners have been flatly ignored by the Government in their opposition to drilling on their lands.</p> <p>It would be environmentally catastrophic and go against the stated wishes of Traditional Owners who are anxious that sacred and culturally important sites are at risk of destruction. Also many remote Aboriginal communities in the Northern Territory have water contamination levels above national guidelines. The Gunner Government's promised industry regulations to mitigate any risk to water have still not been implemented. Which means these fracking corporations could contaminate more sacred water without consequence.</p> <p>Australia does not have unlimited sources of drinking water and that needs to be preserved and looked after. I am proud to live in the NT, to be part of a richly diverse community of Aboriginal nations, people whose families have been in Australia for many generations and the more recent migrants.</p> <p>The environment in the NT is special, the land is sacred. There are many areas of habitat at risk from current and past poor mining practices, and through non-compliance with contractual agreements and legislation.</p> <p>Given this poor practice in the past and continuing now, I am very concerned about the risk of contaminated land, water and the negative impact on culture from fracking. Our future across NT is at risk. I am well informed about the impact of fracking in countries across the world. The risks are too great in comparison with other energy sources including solar with batteries and wind turbines. The Aboriginal people of the NT who will be most immediately impacted by fracking do not consent to this. Many other NT residents like myself do not consent to this.</p> <p>We don't need fracking. We don't want fracking. The risk/benefit does not stack up for the people who live here. It clearly doesn't stack up for the companies without a massive government subsidy.</p> <p>We consider the \$50 million can be better spent invested in solar projects and water sustainability projects in remote NT. Elders have regularly put forward practical project proposals, such as solar farms and battery arrays along the Ghan route and Stuart Highway - reducing the power and communications gaps in the NT.</p> <p>Thankyou for considering my submission.</p> <p>I look forward to your response and to a positive outcome to this inquiry.</p>

The fossil fuel sector is struggling to compete with the increase in cheaper renewable alternatives. They're concerned that even the mining corporations involved (like Empire, Santos, and Origin) have not been able to tell them where the exploration wells will be, how they will impact the underground water, what the final production level mine would look like, or how many wells are being proposed. These Owners have been flatly ignored by the Government in their opposition to drilling on their lands.</p> <p>Vested interests The corporations vying for a piece of the \$50m include Origin, Santos, and Empire. Two of these companies pay zero tax, while the other is led by a multi millionaire who is a major donor to the Liberal Party. The size of Aboriginal land that Empire Energy is planning to frack is almost twice the size of lutruwita/Tasmania. It would be environmentally catastrophic and go against the stated wishes of Traditional Owners who are anxious that sacred and culturally important sites are at risk of destruction.</p> <p>Water contamination Many remote Aboriginal communities in the Northern Territory have water contamination levels above national guidelines. The Gunner Government's promised industry regulations to mitigate any risk to water have still not been implemented. Which means these fracking corporations could contaminate more sacred water without consequence.</p> <p>I implore you to consider not only the environmental impacts of this abhorrent practice, but also the very real impacts for Traditional Owners and other Aboriginal peoples. 		VIC	3126	<p>Dear Committee Secretary,</p> <p>I am pleased to be able to make this submission into the Australian Parliamentary Inquiry into the possible opening up of new gas fields in the Northern Territory's Beetaloo Basin.</p> <p>My name is (withheld). I am a medical practitioner. I write as a doctor, concerned for the future of all children; as an Australian citizen, concerned that we do no further wrongs to the First Australians; and as a scientist, concerned at the huge increase in greenhouse gases which gas from the Beetaloo Basin will cause.</p> <p>I will be brief in outlining the several reasons why this project should not go ahead:</p> <p>Climate Catastrophe. Extracting gas from the Beetaloo Basin is the last thing we should be doing as we respond to the challenge of impending climate catastrophe. The IEA has said clearly there should be no now mining for gas in a world which hopes to achieve net zero emissions by 2050.</p> <p>Gas is not a transitional fuel. There is now clear evidence that fugitive emissions of methane during gas mining and transport make it at least as damaging to the climate as coal and oil.</p> <p>We don't need more gas. Renewable energy becomes more available and cheaper by the day. Australians simply don't need access to more gas.</p> <p>Water extraction. Up to 34 million litres will be required to carry out the proposed fracking, with loss of this precious resource for farmers and traditional owners, as well as the risk of irremediable groundwater pollution.</p> <p>Government subsidies. Proposals include subsidies for roads to and in the area; subsidies for high-risk wellheads; tax breaks for exploration. It is unacceptable to put tens of millions of dollars into these unnecessary, high-risk projects, when there are so many more important needs.</p> <p>Traditional owners. The traditional owners of the land affected have not consented to this process. They fear that their land will be desecrated and their water polluted. They have not been consulted.</p> <p>The companies involved. You don't need me to explain. Origin and Santos: multinationals which continue to minimise their tax and royalties obligations in Australia. Empire: headed by Paul Espie, Liberal Party doyen. Tamboran, whose IPO has already shrunk from \$195M to just \$60M, reflecting the increasingly higher risk of investment in the Beetaloo Basin.</p> <p>The Australian government should block any development of the Beetaloo basin for gas extraction. At the very least, there should be no government support for the process.</p>

I am writing to lodge a submission into the Industry Research and Development (Beetaloo Cooperative Drilling Program) Instrument 2021.</p> <p>Australia has been built on the destruction of Aboriginal lands and communities. It is long past time we stopped. Traditional Owners across the Northern Territory have consistently said no to fracking on their lands. They understand the risks of fracking to their lands, waters and communities and do not want it on their Country. They are also opposed to the tactics of the mining companies who have failed to consult with them; failed to acquire consent; failed to be transparent in their dealings with Traditional Owners and communities; failed to provide information to communities about the long-term impact and risks to water tables, their livelihood and the land on which they live; and failed to respect them. The government has also completely ignored the Traditional Owners and communities regarding their opposition to drilling on their Country.</p> <p>In addition, we don't need the gas, which is a dangerous fossil fuel and will only contribute to further catastrophic climate change. Even the International Energy Agency, generally seen as conservative on climate change, recently announced that the world cannot afford any more fossil fuel projects from this year. There are renewable and cheaper energy alternatives to gas.</p> <p>I fail to understand why, if gas is viable commercially as the federal government claims, it needs to subsidise the potential fracking companies with \$50 million of public money. As it is, two of these companies pay zero tax and the other is owned by a multi-millionaire donor to the Liberal Party. This is an outrageous misuse of public funds which can be much better spent on improving the living and health conditions in indigenous communities, and across the wider community. It also further exacerbates the disrespect shown by the government to the Traditional Owners and communities, who have consistently opposed fracking on their lands.</p> <p>I strongly urge you to take the above issues into consideration in your deliberations and to reject the proposed legislation.
