Senate Inquiry - Social Services Legislation Amendment (Cashless Debit Card) Bill 2017

Dear Committee.

Thank you for the opportunity to appear before you last week. We will provide answers to questions taken on notice shortly. In the interim, we would like to clarify the Foundation's position regarding the methodology used by ORIMA during its evaluations of the Cashless Debit Card (CDC).

The Minderoo Foundation recognise that ORIMA is Australia's largest provider of research, evaluation and data services to Government, and are an independent, external organisation. Given this, we believe their findings are less biased than if the evaluation was done in house by the Government itself or by an interested party with its own natural bias. We believe that this should lend credibility to findings within the final ORIMA evaluation.

We would also like to note that ORIMA's statistical modelling and weighting was done within industry standards and is accepted methodology for extrapolating findings from a sample to the population size. Nevertheless, we recognise that some have criticised the methodology used. We do not believe the evaluation is perfect, particularly given the environment, and we support ongoing evaluation (such as long-term follow-up and evaluation in new sites going forward) to ensure credibility and evidence of impact.

While the initial evaluation only had two waves of data, we believe that findings clearly demonstrate positive impact from the CDC, which was corroborated after seven separate visits by Minderoo Foundation employees to trial sites throughout its duration. We also believe it is worth focusing on what is working and enlarging that across the trial sites. Some impact is better than no impact through business as usual, which we know is not working.

APPENDIX A - ANSWERS TO QUESTIONS TAKEN ON NOTICE

FIRST NATIONS PEOPLE

"...does the Minderoo Foundation employ any first nations people? If so, how many and in what roles?"1

The Minderoo Foundation employs five Aboriginal people. Roles are varied but include our Director of Employment Programs (VTEC), Director of Community Engagement, Executive Assistant to the Chief Operating Officer, and other support positions.

COMMUNITY DEVELOPMENT PROGRAMME (CDP)

"Does Minderoo have concerns about the CDP? Are you aware, for example, of people being removed from the cashless card because they're breaching the Community Development Program?"²

Creating Parity – The Forrest Review makes recommendations in relation to the CDP which the Government has partially implemented.³ The Minderoo Foundation urges the Government to fully implement these related recommendations. We are also aware of the information contained in ORIMA's Final Evaluation, but have not received any direct reports from community members regarding this issue.⁴

TRIAL SITE VISITS

"...could you tell me how many trips have been undertaken and how many politicians you've taken up to various trial sites?"⁷

The Minderoo Foundation has not paid expenses for any politician to visit CDC trial sites. However, representatives from the Foundation have accompanied Mr Ben Morton MP, Senator Skye Kakoschke-Moore, and Senator Jacqui Lambie to CDC trial sites on two separate occasions.
