

I'm writing to you in expression of the disappointment regarding the proposed The Migration Amendment (Visa Capping) Bill 2010 on 26<sup>th</sup> May 2010.

However, I believe this is an unfair bill for most of the International students, considering the following points of view.

Lately, there are many policies have been amended with DIAC, such as the SOL list has been changed. Again it posed more stress to the students and I even heard that someone attempted suicide. I understand the government might have its own concerns, such as unemployment rates. However, the radical change might have negative effects on current applications and many of them have been waiting for a long period, even up to 2 years or more. A refund of money is easy to process but what about the time and effort that has been made so far. Is that refundable too?

Last but not least, we are not terrorists. We love Australia and we want to be a part of it.

I sincerely hope the government will consider carefully before approve this bill and its long-term effect for Australia and its immigration policy.
