Broad dot points from the perspective of the whole program and the Secretariat. Some key points will be that:

- Individual units do not receive funding for policy and law reform from PM&C.
- As a result, cuts will have direct impact on frontline services, as there is nowhere else to take funding from.
- The Secretariat receives some funding for capacity building and related activities. This is only a small portion of the proposed cuts so frontline services in individual units will be impacted.
- Units are already under resourced. Communities are already under serviced. Reductions in service delivery will directly impact on access to justice for Aboriginal victims/survivors of family violence (the majority of whom are women and children). For the majority (if not all units), a 7.4% reduction in staff numbers will make it extremely difficult (or impossible) to provide quality services to existing clients and to communities who have developed trust and expectation in their services.
