

AMENDMENT IN VISA IMMIGRATION CAPPED BILL 2010

- 1. It is not fair to change the immigration laws in the middle application process, as people have already devoted 2 to 4 years of their prime working life in Australia.

This is a unique step that Mr. Evans is going to take as the laws are made for future not for past.
