Data Descriptions/Notes- Table 1:

* Recipients of Newstart Allowance and Jobseeker Payment prior to 29 May 2020 included recipients of Bereavement Allowance and Sickness Allowance as these payments have been subsumed into JobSeeker Payment. This allowed for a better comparison between the recipient numbers. Recipients of Bereavement Allowance and Sickness Allowance recipients are no longer included in this data since 29 May 2020, due to the small number of recipients and subsequent risk of identification of individuals if combined with other publicly available data.

[^] Claims on hand, includes legacy claims for Newstart Allowance, Bereavement Allowance and Sickness Allowance.

Recipients of JobSeeker Payment/Newstart Allowance/Sickness Allowance who are determined to be current (i.e. entitled to be paid) on the Centrelink payment system and not in receipt of a zero rate of payment.

Recipients of Bereavement Allowance/Youth Allowance (other) who are determined to be current (i.e. entitled to be paid) on the Centrelink payment system.

Note: From 20 March 2020, JobSeeker Payment replaced Newstart Allowance as the main income support payment for recipients aged between 22 years to Age Pension qualification age who have capacity to work. Bereavement Allowance closed to new entrants and will cease when all current recipients have completed their bereavement period. Sickness Allowance closed to new entrants and will cease on 20 September 2020.

Note: Newstart Allowance (including Bereavement Allowance and Sickness Allowance) claims reflect claim activities lodged prior to the introduction of JobSeeker Payment on 20 March 2020. Where an outstanding Newstart Allowance claim is granted, the recipient will instead transfer to JobSeeker Payment.

Question:

What steps did the government take to protect those experiencing harm from poker machines taking up other forms of online gambling during the venue shutdown?

Answer:

The Australian Communications and Media Authority (ACMA) relaunched its digital campaign on 20 May 2020 around the risk of using illegal online gambling services under the tag lines ‘even if you win you might lose’ and ‘offshore gambling – don’t bet on it’. The campaign alerted consumers to the lack of consumer protections available on offshore gambling sites and raised awareness that offshore gambling sites are provided to Australians illegally. The campaign linked people to the ACMA’s webpage for further information, including details on how to make a complaint.

In addition, on 29 March 2020, the Australian Government announced a \$200 million Community Support Package (Package) commencing immediately over two years (from 2019-20 to 2020-21) to support vulnerable Australians impacted by coronavirus. Under this package, \$20 million has been provided for financial counselling services and supports, with over \$1.8 million to 33 providers specifically for Problem Gambling Financial counselling services. However, we know the behaviours of people severely impacted by gambling include compulsive stroking of machines, using multiple machines simultaneously, unconscious sweating or crying and overall poor personal hygiene.

What efforts did the federal government take to ensure that state/territory Ministers took these clinical matters into account when agreeing to the timetable for reopening poker machine venues?
