Attention Committee Secretary,

I am writing in regard to the No Jab No Pay legislation the government is currently considering.

As the parent of a child who is now deceased because of his 'immunisations' I want you to know there are a growing number of parents now who are very concerned about this latest government's attempts to coerce parents into a medical procedure they have investigated thoroughly and rejected.
