Dear Senator McDonald

I would like to update the Committee in relation to the Australian Maritime Safety Authority's progress with the changes to Marine Order 504 (Certificates of operation and operation requirements – national law) on passenger safety.

We have drafted the attached amendments to Marine Order 504 to strengthen and clarify requirements for monitoring and accounting for passengers. The key changes are new requirements for:

- operators of certain vessels to count all passengers on board a vessel, at any point where one or more passengers embark or disembark from the vessel, including at a landing point or to undertake a water activity
- recording results of passenger counts in the vessel logbook
- procedures for passenger monitoring so that the master can know or find out the number of passengers on board at any time.

Public consultation opened on 16 December 2019. Given the summer season is a particularly busy period for passenger vessel operators, the consultation period will run for nine weeks and we will accept submissions until 16 February 2019.

Please do not hesitate to contact me if the Committee would like a briefing on AMSA's regulatory approach to enhance passenger safety.
