# **METHODOLOGY & FUNDING**

#### Sample

- Conducted nationally in Australia by Newspoll Limited among **1,201** respondents (2008) and **1,100** respondents (2010)
- Respondents aged 18 years and over.
- Respondents were selected via a stratified random sample process which included:
  - a quota being set for each capital city and non-capital city area, and within each of these areas, a quota being set for groups of statistical divisions or subdivisions;
  - random selection of household telephone numbers using random digit dialling (RDD);
  - random selection of an individual in each household by a "last birthday" screening question.

#### Interviewing

- Conducted by telephone over the period of 1-8 May 2008 and 1-14 March 2010 by fully trained and personally briefed interviewers.
- To ensure the sample included those people who tend to spend a lot of time away from home, a system of call backs and appointments was incorporated.


#### Weighting

- To reflect the population distribution, results were post-weighted to:
  - Australian Bureau of Statistics data on age, highest level of schooling completed, sex and area;
  - federal voting intention (using the previous two Newspoll voting intention surveys) (2008 only).
- Results presented as weighted, showing population estimates represented by the respondents, expressed in thousands. The percentages are based on these weighted figures.

#### Funding

• Funded by the Australian Research Council, Discovery Project DP0666833, led by Griffith University, with Charles Sturt University, University of New England and the University of Melbourne.


# Australians' satisfaction with democracy

# Australians' satisfaction with how three-levelled system works (in general)

As you probably know, Australia has a system of government with **three** main levels - there's the **federal** government, **state** government and **local** government, that is, local councils. Overall, how well would you say this system of government works in Australia?

The current system of government, with three main levels, <b>does not work well</b>	30%	35%
The current system with three main levels, works well – but system does <b>not deliver</b> <u>legislative diversity</u> , <u>innovation</u> , or <u>collaboration</u> well	39%	40%
Did not respond negatively to above, but <u>legislative diversity</u> , <u>ability to innovate</u> , <u>division of power</u> , or <u>ability to elect different parties</u> <u>at different levels</u> , is <b>undesirable</b>	17%	15%






