# Northern Australia inquiry returns to Queensland

The Australian Parliament's Northern Australia Committee is returning to Queensland next week to hold public hearings in Cairns and Thursday Island as part of its inquiry into the region's economic future.

The Committee will hold public hearings on 28 and 29 April in Cairns where it will hear from a range of stakeholders representing current industry strengths, such as tourism, and areas for development in agriculture, mining and tropical medicine. The potential environmental impacts of development proposals and the implications for resource management more generally will also be discussed.

On 29 April, the Committee will explore development proposals from the perspective of Aboriginal title owners. The Ewamian Aboriginal Corporation and Chuulangun Aboriginal Corporation will talk to the Committee about their aspirations for effective management of land and water in the North.

On 30 April, the Committee will hold public hearings on Thursday Island to learn about challenges and opportunities across the Torres Strait. Torres Strait Islanders have traditional trade connections with Papua New Guinea and other regional nations but must now manage biosecurity risks presented by the close proximity of these neighbours.

Committee chair Warren Entsch said he looked forward to hearing a wide variety of views about the way forward for the economic prosperity of northern Australia.

"Northern Queensland is a dynamic part of Australia which is already attracting large numbers of international visitors as well as being a place in the sun for Australian retirees and those just wanting time to relax. But there is much more to the North than tourism: its proximity to key trade partners, richly diverse natural environment and resource wealth offers enormous opportunities that are still largely untapped," Mr Entsch stated.
