Dear Chair

I refer to the recent hearing of the Senate Select Committee on the National Broadband Network (the Committee) on Friday 3 October 2014, at which officers from the Department of Communications appeared as witnesses.

During the course of the hearing, costs related to the recent National Broadband Network (NBN) reviews were discussed. In particular, there were questions regarding expenses relating to the Centre for International Economics (CIE) consultancy since May 2014.

The figures I quoted in the hearing were GST exclusive. To ensure consistency with answers previously provided to members of the Committee (eg in the response to Question on Notice 526 from the May 2014 Budget Estimates Hearings), please find attached to this letter a table of updated expenditure for Vertigan Panel work with GST inclusive figures where applicable. The figures provided represent total costs current as at 30 September 2014 and are close to final given that the Vertigan Panel has now concluded its work. All figures include travel expenses.

I would like to clarify that the breakdown of figures to be paid to CIE provided in Question on Notice 27 from the 5 May 2014 hearing of this Committee was based on estimates provided by CIE of subcontractor amounts, within the overall maximum contract amount of \$765,900.

Since then, the Department has increased the contract with CIE to enable CIE to develop a version of the model of the Cost Benefit Analysis that can be made available for members of the public to run scenarios, and to provide for CIE's attendance at the

Committee. As a result, the total maximum value of the contract with CIE is \$783,225 (GST inclusive). Actual payments to CIE as at 30 September 2014 (attached) are within both the earlier and current quoted maximum amount.
