**Submission to the Senate committee reviewing the
*Environment Protection and Biodiversity Conservation Amendment
(Retaining Federal Approval Powers) Bill 2012***

**Thank you for the opportunity to contribute to the Inquiry into the
Environment Protection and Biodiversity Conservation Amendment
(Retaining Federal Approval Powers) Bill 2012.**

**In connection with the proposed bilateral agreements with states over the
EPBC Act, our membership, the Logan and Albert Conservation
Association (LACA), believes that conservative state governments are
clearly pursuing ideological objectives when they call for reductions in
Federal Government involvement in environmental issues. Ideologies come
and go, but environmental issues are growing and need to be treated with
great seriousness and not be allowed to become part of an ideological
chess game.**

**The conservative states are laying the blueprint for an Abbott
reconstruction of Australian Government along the lines of the UK 'Big
Society', which, through austerity measures, devolves government
progressively down to local regions and hands much of the management of
our key institutions to corporations. This would be highly undesirable and
un-Australian, utterly unnecessary for a successful economy such as ours,
and catastrophic for the environment.**

**Short-sighted development proposals, supported by the states, have
threatened Australia's natural heritage many times in the past. A healthy
environment is essential to the Australian way of life. Due to poor State
laws and lack of effective compliance processes, our environmental assets
are in a state of decline. We need stronger environmental laws, not weaker
ones.**

**For the current Federal Government to devolve the EPBC assessment
process down to the state level at the same time as the conservative states
are busy dismantling and de-powering their environment departments
would be short-sighted in the extreme, and would bring to an abrupt end
the fine record of wise Federal interventions in key environmental issues,
such as Fraser Island, The Wet Tropics and Franklin River – all of which**

have been recognised around the world as proud moments in Australia's history.

Strong environmental laws safeguard our way of life. They protect our land and wildlife and ensure that our air and water are not polluted by destructive development.

Our membership is deeply concerned that under pressure from industry, conservative state governments are vigorously pursuing aggressive plans to wind back the critical environmental protection laws that safeguard our land, water and wildlife, and the Bilateral Agreement proposals relating to the EPBC are a significant part of this. Faced with this, the Federal government must not abdicate from its responsibility to continue playing a critical role in protecting matters of national environmental significance.

We call on you to reject the proposals laid out in the Council of Australian Governments (COAG) agenda that would fast-track the transfer of federal approval powers to state governments, wind back the Environmental Protection, Biodiversity and Conservation Act and allow states and territories to fast-track environmentally damaging development projects.
