As my husband and son work feverishly to strip the last remaining wheat, racing against the rain I cannot fathom the absolute stupidity of this whole debacle you call a 'Plan'.

While you people sit in your ivory towers at the top of the hill in Canberra, real Australians with a real passion to work and provide a future for our nation are forced to fight for our right to continue producing food.

At the most busy time of year (our 1<sup>st</sup> wheat harvest in years, 2 weeks before Christmas, fighting against the inclement weather - flood - after a 10 year drought) we are forced to submit our letters by today, when the MDBA have had 3 YEARS! To produce this waste of paper called a "Guide to a proposed plan". If we farmers ran our businesses the way this committee has wasted tax payers dollars on this, we all would have been broke years ago.

My husband and I have been farming together for 22 years and we are 3<sup>rd</sup> generation farmers. We have 4 children, one of whom was thinking of joining us in the business at the end of year 12 in 2011 to become our 4<sup>th</sup> generation in the family business, but his future is now uncertain. Does my son's future farm employment prospect count as one of your ridiculous 800 job losses, discussed in this plan? I am not educated nor am I a scientist, but the people or person responsible for calculating this figure should be sacked immediately for ignorance and stupidity.

In Griffith already the feeling is very negative; confidence is low as is proven by the increase in advertising for house sales and the drop in the real estate market and business expansion.
