## 2 Opening of the meeting

The meeting was opened at 9.30 by the Chairman Colin Blair.

### 2.1 Apologies

Apologies received from A/Prof Hui Tong Chua, , Mark Klop, Tasman Twyman, Wayne Webley, Artur Lenkiewicz, Clem Cook, Rod Baily, Ian Gallagher, Lou Wiersma and Mark Klop were tabled.

## 3 Confirmation of the minutes of the previous meeting

The minutes of the 24th meeting held on 28<sup>th</sup> and 29th Nov 2006 was confirmed as a true and correct record.

## 4 Matters arising out of minutes

Committee requested to extend the preliminary comment submission for revisions of AS/NZS 2918 as there are many members who could not send the comment due to delay in circulating the minutes. The comments period was extended and WG meeting will be scheduled to consider the preliminary comments.

## 5 Current Work Items

### 5.1 Item No. 1: Resolution of comments of Doc No CS-062-R0026 and R0028: DR 06661 CP - Project No: 4215 - Domestic Solid Fuel Burning Appliances - Method for Determination of flue gas emission.

The committee discussed and resolved the comments of the above DR06661CP as follows:

#### 5.1.1 Clause 7.1

The Committee extensively discussed the need to reduce the emission limit further from current specified 4 g/kg. Discussion centred on the lack of change to the standard since 1999 in light of multiple submissions from members and the general public calling for a reduction in the particle emission factor.

The committee agreed that this was overdue given the that any change as a result of work being progressed by the sub-committee on real life emissions would realistically require another five years before adoption. The committee agreed to a reduction to 3.0 g/kg with the majority further in agreement that 2.0 g/kg was more appropriate.

**ACTION:** Industry representative to consult the manufacturers to consider reducing the emission limits to 2 g/kg. PM to circulate the notification non-attending member about this decisions and requesting to seek the view of the industry to reduce the emission limit to 2 g/kg.

{PM Note: The resolutions of Comments and the Committee decision to reduce the emission limit to 3 g/kg were circulated. The industry representatives were informed to report back by 5<sup>th</sup> April (within 2 weeks of circulation of e-mail) regarding the view of the industry on this further reduction of emission limits to 2 g/kg}.

In addition to this, the committee further proposed to introduce a minimum efficiency of 50%. This is simply a 'backstop' provision to ensure that emissions reductions are not achieved at the expense of operating efficiency (in some instances it may be possible to significantly increase air flow to reduce emissions).

#### 5.1.2 Clause 9.2: Retesting exemption

The Committee discussed and decided the need to review the retesting exemption and decided to redraft the 9.2 including an informative appendix as retesting exemption guide.

**ACTION:** Bill Yeo was requested to redraft and submit the revised text.

#### 5.1.3 Section 10: Marking

The Committee consider the need to include warning under the Marking clause and discussed the how this marking information will be drafted since the need for health warning are reiterated by 5 different comments including Aust' Lung Foundation. The Committee decide to seek advice from Health authorities about the suitable health warning and requested Michael Chertock to check with Dept' of Health regarding this matter and advice Committee on suitable health warning to add to the marking.
