Dear Mr Kirby

I refer to your email dated 12 October 2017 at 6:02PM.

Your email contains a date reference which is clearly in error. I have assumed you wish the response by 20 October 2017 (not 20 September 2017). Please see the Committee Secretary's letter enclosing one question and the response date.

The question 20 is not identified but refers to transcript. The transcript refers to the Senators "understanding" of two meetings on 6 February 2015. The Senators understanding is erroneous and I was not informed of the basis of her understandings.

My diary reveals that the date of 6 February 2015 was the date of the Weary Dunlop lunch. This is a social occasion held at Crown Casino in Melbourne as a fund raising event. I had no formal meetings with any person. I would have spoken at the lunch as the President and met and spoke informally to hundreds of people.

I did not meet with any unidentified investment banker nor Mr Andrew Cox at a formal meeting. I am not sure whether such persons were in attendance at the Weary Dunlop lunch.

This "understanding" of the Senator seems to have been undermined by later evidence on the same day I gave evidence.

Unfortunately, the Senator asserted I was "a little hazy about it" to Mr Leahy (transcript page 43). The transcript then records Mr Wellborn (wrongly as it was Mr Leahy) and he states: "Mr North wasn't in those meetings".

If it was Mr Leahy who founded the basis of the Senator's understanding then it would seem that he clarified the position that I was not in attendance at "those meetings". Further, it is not clear the meetings were about having regarded to the later evidence on the same page.

I assume therefore that the question has been answered satisfactorily. I was <u>not</u> at any meetings of the type enquired of by the Senator of by the Senator.

#### **Question 20**

**Senator REYNOLDS:** Thank you. I understand there was a meeting in Melbourne on 6 February 2015 when Rob Clarke went down to Melbourne. He had two meetings, which I understand may have been with you and, first of all, an investment bank—I don't know who it was; the name escapes me—who apparently fell through.
