Question:

For each DSS payment – including the Age Pension, Disability Support Pension, Carer Payment, JobSeeker, Youth Allowance and Parenting Payment:

- a. In each fortnight since the start of February, how many people on have declared income from employment and how many people have not declared any income from employment?
- b. What was the mean and median income declared in each fortnight?
- c. How many hours have people worked – mean and median – in each fortnight?
- d. How does the number and proportion of people on each payment declaring income from employment, and the mean and median income and hours declared differ to the same period in 2019?

Answer:

Data on employment income is only available at monthly intervals. Please find the answer in **Attachment A**. Earnings relate to the employment earnings reported in the last fortnight of the month.

Data Descriptions

Includes the following recipients:

Recipients of JobSeeker Payment who are determined to be current (i.e. entitled to be paid) on the Centrelink payment system, and not in receipt of zero rate of payment.

JobSeeker Payment is the main income support payment for recipients aged between 22 years and pension age (the minimum qualifying age for Age Pension), who have capacity to work now or in the near future. JobSeeker Payment is available to people who are looking for work, who temporarily cannot work or study because of an injury or illness, or bereaved partners in the period immediately following the death of their partner, subject to meeting eligibility requirements. Data includes recipients who are determined to be current (i.e. entitled to be paid) on the Centrelink payment system and are not in receipt of a zero rate of payment. From 20 March 2020, JobSeeker Payment replaces Newstart Allowance, Bereavement Allowance and Sickness Allowance. Bereavement Allowance closed to new entrants on 20 March 2020 and the payment will cease when all existing recipients have completed their bereavement period. Sickness Allowance closed to new entrants on 20 March 2020 and the payment will cease on 20 September 2020. In other published sources, recipient counts of Newstart Allowance and JobSeeker Payment may include recipients of Bereavement Allowance and Sickness Allowance, as these payments have been subsumed into JobSeeker Payment. This combining of payments allows for a better comparison between the recipient numbers. In this report each individual payment is shown separately and the numbers of Bereavement Allowance and Sickness Allowance recipients are not shown. This is because the number of Bereavement Allowance and Sickness Allowance recipients in some cells needs to be confidentialised due to small numbers (less than 5). As such, a combined JobSeeker Payment number (which sums Jobseeker recipients, Bereavement Allowance recipients and Sickness Allowance recipients) has not been provided as this could result in the actual number in the confidentialised cells being derived if combined with other publicly available data.

Recipients of Parenting Payment and Youth Allowance who are determined to be current (i.e. entitled to be paid) on the Centrelink payment system.

Recipients of Age Pension, Carer Payment and Disability Support Pension who are determined to be current (i.e. entitled to be paid) or suspended on the Centrelink payment system.

Earnings refers to employment earnings reported in the last fortnight of the reported period.

These data may not be an accurate record of the recipients hours worked per fortnight because it is self reported.

Note: Reported Mean and Median earnings and hours worked are calculated for recipients with recorded earnings and hours worked only. Those recipients with missing earnings or hours worked have been excluded from the calculation.

Question:

How many people on the Disability Support Pension, Carer Payment and Age Pension have stopped declaring income from employment, declared reduced income from employment or declared reduced hours of employment since February?

Answer:

The report in **Attachment A**, includes all persons who were:

- in receipt of Age Pension on both 28 February 2020 and 29 May 2020;
- Disability Support Pension on both 28 February 2020 and 29 May 2020
- Carer Payment on both 28 February 2020 and 29 May 2020.

For each individual person, comparisons of their reported earnings amount and their reported hours worked are made between the two periods to determine whether they had either increased, decreased or remained the same in respect of their reported earnings amount and whether they had their either increased, decreased or remained the same in respect of their reported hours worked. The report also identifies persons who had a reported earnings amount in February 2020, but no reported earnings amount in May 2020. The report identifies persons who did not have a reported earnings amount in February 2020, but did have a reported earnings amount in May 2020. Finally, the report identifies persons who had no reported earnings amounts in both February 2020 and May 2020.

The report does not capture any changes in either earnings amounts or hours worked that may have taken place during the fortnightly payment periods between 28 February 2020 and 29 May 2020.

As only those people who were on these payments as at 28 February 2020 and 29 May 2020 are captured, the totals in these tables will not match with total recipients on each payment on either date.

The population includes all persons who were in receipt of Age Pension/Disability Support Pension/Carer Payment at both points in time, 28 February 2020 and 29 May 2020 and compares whether they had earnings in neither, one or both reporting periods.

Earnings refers to employment earnings reported in the last fortnight of the reported period.

These data may not be an accurate record of the recipients hours worked per fortnight because it is self reported.

The report does not capture any changes in either earnings amounts or hours worked that may have taken place during the fortnightly payment periods between 28 February 2020 and 29 May 2020.

As only those people who were on these payments as at 28 February 2020 and 29 May 2020 are captured, the totals in these tables will not match with total recipients on each payment on either date.
