Quoting David Suzuki, "Fracking has to be one of the dumbest, most shortsighted, and most dangerous practices. Fracked gas is released by pumping massive amounts of water and sand containing dozens of chemicals, including known carcinogens, under high pressure into wells deep underground. The gas released is methane, a greenhouse gas that is twenty-two times as potent as CO2 and there is a high rate of leakage. Water pumped into wells is contaminated and can flow into underground waterways. Fracking clearly indicates the lack of concern for consequences. Aboriginal communities have said NO FRACKING. on their land for years. The Government's plans to give \$50million of public moneys to oil and gas companies is outrageous. There is no plan for wastewater from the fracking wells, putting communities and water at risk of contamination.

I prefer that the Government prioritises funding on renewable energy and healthcare.

I would prefer the government spend money on housing and healthcare .

I would like to thank you for the opportunity to make a submission opposing fracking in the Beetaloo Basin in the Northern Territory and the plan by our government to give \$50,000,000 to oil and gas companies. In 2021 we need to be thinking about the effect our actions have on the environment and the liveability of our country for generations of Australians to come. Now is the time for us as a nation to be thinking about renewable energy. Gas has become so expensive that it is a huge strain on the budgets of many Australians and sadly fracking is unlikely to improve this situation, despite the lip service paid to the notion. I oppose any government approval of fracking in the Northern Territory and, even more so, any government money being diverted into support for this destructive industry. The traditional owners don't give consent to this industry which spoils land and water and puts at risk the local environment and other industries such as agriculture. Furthermore, the fracking of gas is a massive contributor to greenhouse gas emissions which drive climate change around our whole precious planet. We must switch immediately to renewable energy to give future generations some hope of a livable planet beyond 2050.

I object wholeheartedly to our hard earned taxes being used to contribute to green house gases, as well as risking the contamination of the water in this arid land, and destroying aboriginal sacred sites.
The time is overdue for the government to listen to the voices of the people who pay their wages

I object to the handing over of tax payers funds to undertake fracking for gas in the Beetaloo Basin.
My objection to this activity is based upon the experience I had with the on-going non-compliance with environment protection measures I witnessed by Sydney Gas in the Camden Coal Seam gas project.
Gas fracking causes much greater risk of long term water pollution which only becomes evident long after depletion of the gas. The company involved has no responsibility for any clean-up or future compensation to affected parties.
Coal seam gas extraction creates large quantities of contaminated water and solid wastes which the company doing the extraction evades responsibility for. The wastes get dispersed around the countryside and landowners are left with dumped wastes with no compensation required for proper environmental protection. Dumped wastes are a long term problem because the gas extraction company lacks the financial profitability to properly transport and disposed of the waste in licensed and controlled facilities providing long term protection from future environmental harm.
The financial viability of gas extraction is now open to question. The true cost of gas extraction is not being reflected in internalised costs. For example, water pollution from contaminated water storages and improper waste disposal is not reflected in actual costs. Clean-up costs are not covered by mandatory financial guarantees with sufficient funds to cover complete clean-up and rehabilitation.
For these reasons, I request that no tax payer funds be gifted to the operators of gas fracking activities including the infrastructure for marketing of gases retrieved by such operations.

I object to any expansion of gas or oil fracking in the Beetaloo Basin.
Based on my years of witnessing deleterious effects of coal mining near my home, all reassuring by authorities and mining companies will prove false. Your rivers and precious groundwater will be degraded, your communities divided and depleted your cultural heritage removed and broken all dominated by exaggerated claims of wealth to be created. Due to the well-known consequences of the climate catastrophe already upon us, shame on all putting forward further expansion of mining coal, fossil gas and oil.
