With reference to Mr Bao Hoang's NCC biography released 27 July 2020:

- 1. What financial, pecuniary or management interests does Mr Hoang hold in Revita, an aged care services provider?
- 2. Has Mr Hoang disclosed Revita's relationship with Healthcare Australia, noting that Revita was acquired by Healthcare Australia in 2018? If yes, can a copy of that declaration be provided?
- 3. Was the Department aware that Healthcare Australia is currently contracted by the Department of Health to provide surge staffing in aged care? (CN3696885)
- 4. How are any conflicts of interest between Mr Hoang's business interests in aged care and his role on the NCC being managed?

#### **Answer:**
