RE: JP157 – REPLACEMENT AVIATION REFUELLING VEHICLES INFRASTRUCTURE PROJECT

In reference to the Inquiry into the JP157 – Replacement aviation refuelling vehicles infrastructure project, the following and attachment constitute the submission by Ipswich City Council.

RAAF Base Amberley is located in the Ipswich Local Government Area. In reviewing the report before the Committee, it is apparent that there is an error in the site plan that, when viewed in conjunction with the text of the report, leads to uncertainty regarding the location of works proposed at RAAF Base Amberley and the nature of those works.

In section 27 (Page 12) of the report the proposed works at RAAF Base Amberley are described as:

“27. The proposed works include:

- a. **Bunding Works** to extend the existing fuel farm dispense bunding over existing hardstand on the South Eastern end.
- b. **Contamination works** are required to the site.”

The site plan in Attachment 2.2 shows the construction of a new shelter. Furthermore, Attachment 2.2 does not show RAAF Base Amberley but rather replicates (erroneously) the site plan in Attachment 4.2 that relates to RAAF Base Townsville (refer to Attachment A).

It is requested that works at RAAF Base Amberley are confirmed as being those described in Section 27 of the report and that the site plan in Attachment 2.2 is amended to reflect the actual location, nature and extent of works at RAAF Base Amberley.


