#### Question:

Senator SIEWERT: ............I want to go to the Mable tender process for the surge workforce in March. I'm sure you'll have heard the reports about the contract. Is it correct that it was a \$5.8 million contract?

Mr Lye: I think that's right.

Ms Laffan: That's the original value of the contract, yes. Senator SIEWERT: You said 'original value'. How much—

Ms Laffan: The contract value is now \$6.6 million, GST exclusive.

CHAIR: Why has it gone up? Sorry, Senator Siewert. Senator SIEWERT: How was the decision made to take—

CHAIR: Sorry, I just jumped in and asked why it had increased.

Ms Laffan: It was due to additional services which we asked Mable to perform, including

concierge services.

CHAIR: Sorry—Senator Siewert.

Senator SIEWERT: Are they still providing services?

Ms Laffan: They are, yes.

Senator SIEWERT: Who are they providing services to?

Ms Laffan: I don't have the names of the specific aged-care providers. I have a total figure in

terms of shifts provided.

Senator SIEWERT: Up-to-date you mean? How long are they contracted for?

Ms Laffan: Their contract is until 30 September, and we're in negotiations with Mable at the moment around potentially extending that contract.

Senator SIEWERT: I think it will take too long for you to go through the list; are you able to

provide a list of services they've contracted to provide, and to whom?

Ms Laffan: Which home and residential services have used Mable?

Senator SIEWERT: Yes.

Ms Laffan: Yes—funded through our program, yes we can.

Senator SIEWERT: Okay, please take that on notice.
