COMMUNITY CONSULTATION REPORT
ALBURY WODONGA MILITARY AREA REDEVELOPMENT PROJECT

1. The Albury Wodonga Military Area Redevelopment Project was referred to the Parliamentary Standing Committee on Public Works on 27 March 2024. The project proposes to deliver facilities and infrastructure at the Albury Wodonga Military Area, New South Wales and Victoria. The project will be delivered together with the RAAF Base Wagga Redevelopment Project and the Blamey Barracks, Kapooka, Redevelopment Project, under a combined program to maximise construction and cost efficiencies.
2. This letter is to inform the Committee of the nature and extent of community consultation that has been undertaken by the Department of Defence for these proposed works. The aim of the consultation is to ensure local communities and other stakeholders are:
 - a. well informed about project details through effective and proven communication channels; and
 - b. provided the opportunity to raise any concerns or issues, or to seek further information so that, wherever feasible, Defence could address these in its proposed works.
3. The following stakeholder and community consultation activities were delivered in accordance with the project's comprehensive community engagement strategy:
 - a. Community information sessions were advertised in local newspapers and on social media in Albury and Wodonga. The project also established a webpage, email address and phone number to receive questions about the project. These details are included in the example advertisements in **Annex A**.
 - b. Letter box drops were conducted between 22 and 26 November 2023 and between 26 and 28 April 2024. Details of the letter box drops are in **Annex B**.
 - c. Four community information sessions have been held in Wodonga; two sessions on 4 December 2023 and two sessions on 15 May 2024. The information Defence presented to the public is in **Annex C**, and the level of attendance is in **Annex D**.

4. Key stakeholders, including Federal, State and Local Members of Government, and local community members were offered a personal briefing on the project. An example of the invitation that was sent out is in **Annex E**. A list of all stakeholders engaged by the project, including the status of each engagement, is provided in **Annex F**.

5. Information about the proposed works was generally well received at the community information sessions and feedback to date has been positive. Defence has not been made aware of any objections to the proposed works.

6. Comments raised by members of the community focused on:

- a. opportunities for local industry participation in the proposed work;
- b. opportunities for training; and
- c. concerns around the local market's capacity to support the proposed works.

7. A summary of topics and key issues raised during community information sessions is provided in **Annex G**.

8. Consultation activities have concluded. Defence will provide a briefing to Federal, State and Local Members of Government contacted during the consultation process should they request one.

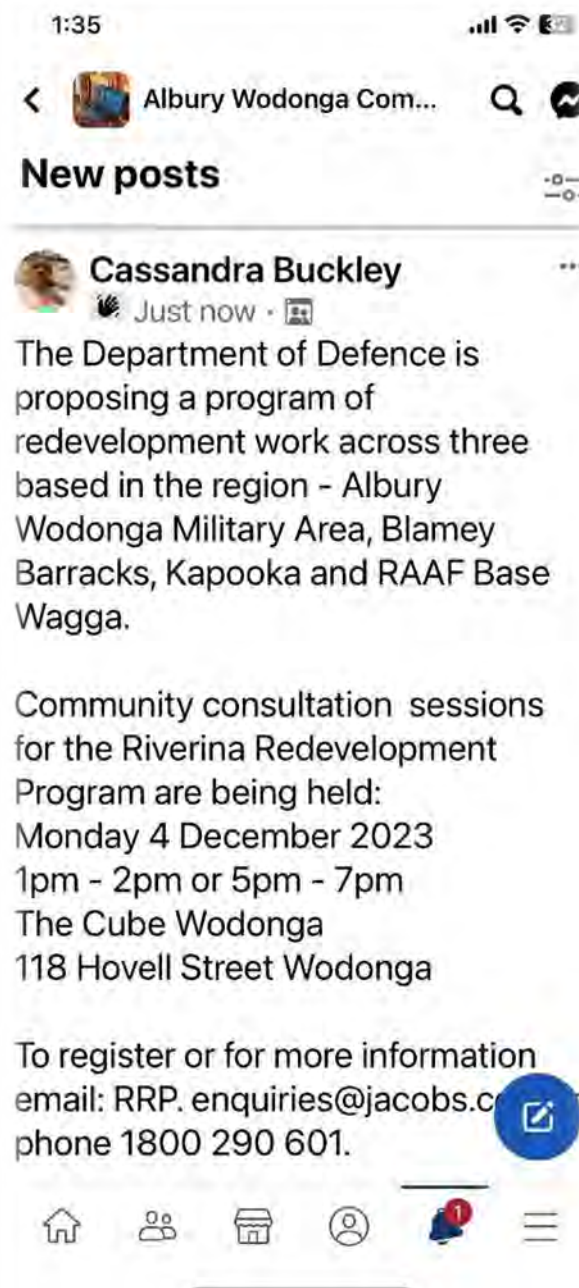

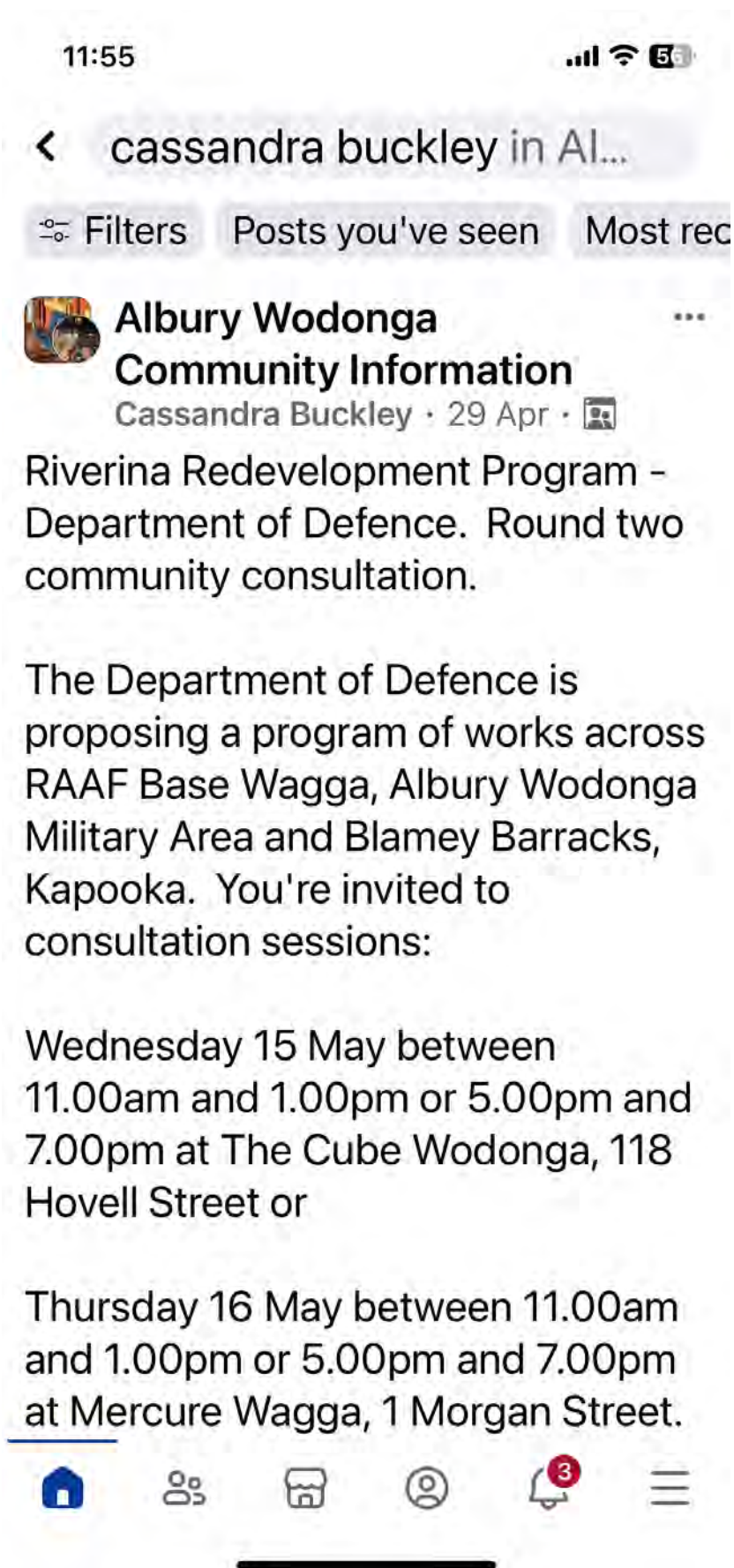

Overview

The proposed Riverina Redevelopment Program will improve and expand the facilities and infrastructure at the Royal Australian Air Force (RAAF) Base Wagga, Blamey Barracks (Kapooka) and the Albury Wodonga Military Area.

The proposed program is part of the broader efforts to recruit, train and retain Australian Defence Force (ADF) personnel to meet future defence needs.

The facilities and infrastructure at the bases are aging and unable to meet the needs of an expanding ADF. The program will provide the facilities and infrastructure needed for the increase in personnel numbers.

The Riverina Redevelopment Program received 2 Minister approvals on 7 December 2023.

Community information

Defence is committed to providing the community with accessible and transparent information about the program and will provide opportunities to offer feedback.

The Albury Wodonga Military Area Redevelopment Project and RAAF Base Wagga Redevelopment Project were referred to the Parliamentary Standing Committee on Public Works (PWC) on 27 March 2024.

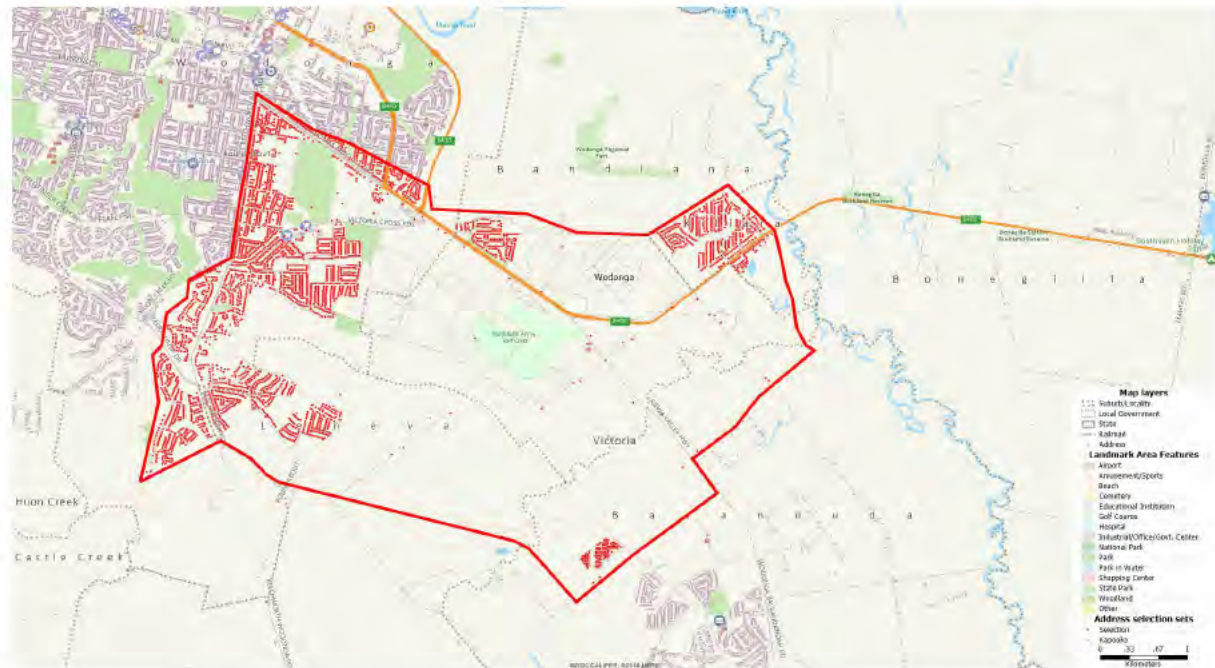

About the Riverina Redevelopment Program

The Department of Defence (Defence) is investing in the growth, retention and training of Australian Defence Force personnel.

To support this growth, Defence is proposing a program of works across three sites in the regional areas of Hume, Riverina and Murray, through the delivery of the Riverina Redevelopment Program. The program will be delivered at:

- Albury Wodonga Military Area
- RAAF Base Wagga
- Blamey Barracks, Kapooka

The Program will create larger, safer and fit for purpose facilities across the three bases by improving current facilities and constructing new buildings and infrastructure. The proposed works will also create safer access for vehicles and pedestrians around the three bases.

Benefits of the Riverina Redevelopment Program

The Program will:

- Provide modern facilities for the Australian Defence Force personnel to live, work and train.
- Enable local employment and training opportunities
- Support long term growth for communities in the Riverina, Murray, and Hume regions.
- Enable supply and delivery of construction services from the local and regional market

- New Cadet and Army Reserve Multi-User Depot

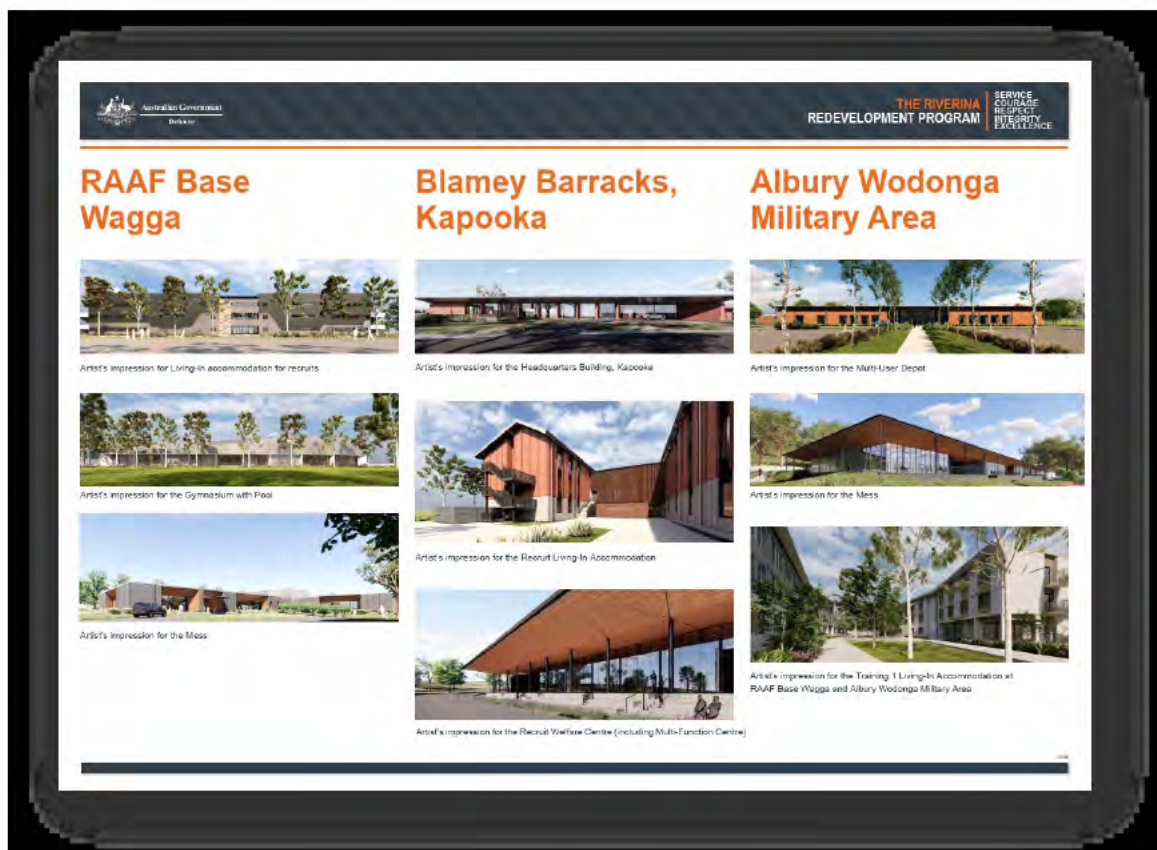
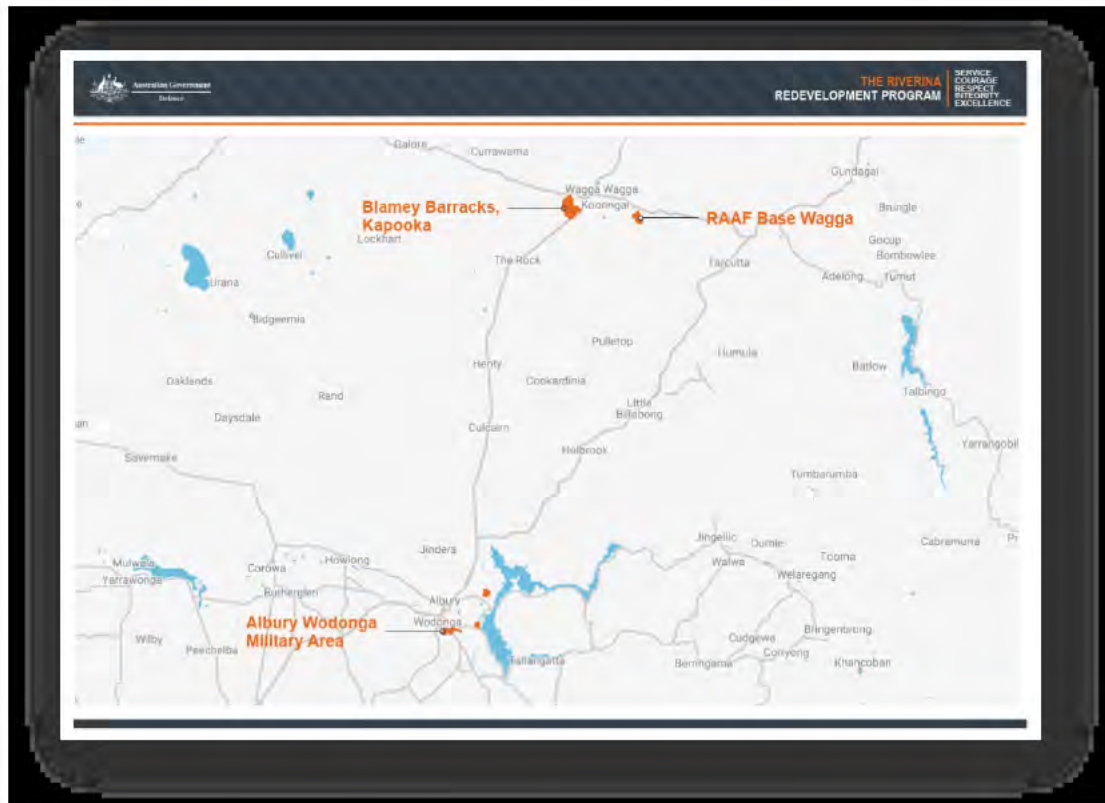
Timeframes

The benefits of the Riverina Redevelopment Program:

- The Riverina Redevelopment Program will create a safer place to live, work and train for our Australian Defence Force personnel.
- The Program will support jobs and investment in the Riverina and Murray Valley regions, and will ensure the benefits are shared with the local communities.
- If approved, the Riverina Redevelopment Program will prioritise hiring locals and using local businesses in Albury and Wodonga during construction.
- The Program will create safer road access into Albury Wodonga Military Area for all road users.
- Defence's design process has taken a Designing with Country approach to ensure the inclusion and integration of First Nation voices.

Managing and mitigating potential impacts

All the proposed works will occur on land managed or owned by Defence, State Government Agencies or the Council.

The Riverina Redevelopment Program team has taken a considered design approach to minimise and mitigate any potential impact.

The proposed works include the construction of a new and safer road entry into Gaza Ridge Barracks, South Bandiana. It has been designed to mitigate current issues with traffic and pedestrian interactions at the site. This will be a safer outcome for all road users. This design will need to be endorsed by VicRoads as the local road authority.

As a result of the need to create a safer road entry, several trees that form part of the Avenue of Honour for the Vietnam War will be impacted. The Riverina Redevelopment Program will work closely with Vietnam Veterans and the key stakeholders to help identify a potential offset to the planned impacts to the Avenue of Honour.

Details

Two community information sessions were held on Monday 4 December 2023 at The Cube, 118 Hovell Street, Wodonga, Victoria. The sessions ran from 1.00pm to 2.00pm and 5.00pm to 7.00pm. Defence held the sessions during and after business hours to allow community members with competing time commitments, the opportunity to attend.

A small group discussion was held with interested stakeholders regarding the ‘Avenue of Honour’, which commemorates those who served in the Vietnam War. The proposed Albury Wodonga Military Area Redevelopment project will impact the ‘Avenue of Honour’ by removing some trees. This session was held at 2.00pm on 4 December 2023, with attendance both in person and online. Stakeholders interested in the session were invited by phone.

A second round of community consultation sessions were held on Wednesday, 15 May 2024 at The Cube Wodonga, 118 Hovell Street, Wodonga, Victoria. The sessions were conducted between 11.00am to 1.00pm and 5.00pm to 7.00pm.
