#### Question:

With reference to the opening statement by the Acting Secretary on 23 April 2020: What is "Australia's National Incident Room" and what caused it to be activated on 20 January 2020.

#### Answer:

The National Incident Room (NIR) is the Department of Health emergency operations centre. The NIR responds to health events of national significance, both nationally and internationally. The NIR acts as a conduit for response and recovery operations within the Department of Health and between state and territory health authorities, other Commonwealth operations centres and the international health community. The NIR represents the Department of Health as the lead agency in coordinating national health responses to communicable disease outbreaks.

On 1 January 2020, the Department of Health began monitoring the pneumonia cluster in Wuhan, China. On 5 January 2020, the World Health Organization (WHO) advised the Department of Health, as the International Health Regulations National Focal Point of Australia, of a cluster of pneumonia of unknown etiology reported in Wuhan City, Hubei Province of China.

On 9 January 2020 the WHO reported that Chinese authorities had made a preliminary determination of a novel (or new) coronavirus, identified in a person hospitalised with pneumonia in Wuhan, China. The potential for severity demonstrated by other coronaviruses

(e.g. MERS-CoV and SARS-CoV), and reported severity in some patients infected with this novel coronavirus, led to intense global interest and concerns around disease transmission.

By 20 January 2020, there had been 202 cases diagnosed with novel coronavirus, including two in Thailand, one in Japan and one in South Korea. Open source media was reporting far greater numbers, and given the spectrum of clinical symptoms at that time, it was likely that individuals with mild symptoms or who were asymptomatic, remained undetected.

On 20 January 2020, the Department convened an extraordinary meeting of the Communicable Diseases Network Australia to discuss the escalating situation. Members agreed a nationally coordinated health sector response was advisable to ensure consistent public communications and escalated response measures. Accordingly, the NIR was activated that same day to coordinate the national health sector response to the novel coronavirus outbreak.

#### Question:

Can details be provided of the joint exercise with New South Wales Health in May 2019 related to a pandemic in a cruise ship coming into Sydney.

#### Answer:

Exercise EmergenSea Detour, was conducted on 1 May 2019 at the Department of Health's central office in Canberra.

The aim of the exercise was to strengthen the capacity of Health and the Department of Agriculture, Water and Environment (DAWE) to work effectively together to manage human biosecurity emergencies, with a particular focus on roles and responsibilities for cruise ships. Health and DAWE work together in a number of areas, with management of responsibilities under the *Biosecurity Act 2015* a key area.

The exercise also acknowledged the critical role of state and territory governments in the scenarios and included an examination of interaction with these agencies.

Three state health services participated in the exercise to assist with providing information about the range of those interactions - NSW Health, the Department of Health and Human Services Tasmania and the Victorian Department of Health and Human Services.

The particular focus of this exercise was on building a better understanding of agencies' priorities, needs and processes. Clinical management of cases and jurisdictional public health arrangements were out of scope for the exercise.

The Australian Health Protection Principal Committee (AHPPC) has endorsed national principles for the resumption of sport and recreation activity in Australia. The AHPPC has endorsed the formation of a COVID-19 Sports and Health Committee to provide any further and specific decisions about the resumption of sport and to monitor and report on any COVID-19 related issues in the sector during the resumption phase. This Committee will comprise of the Australian Institute of Sport Medical Director, an infection control expert, representatives of jurisdictions and the Commonwealth Deputy Chief Medical Officer.

The AHPPC discussed the NRL proposal and determined the specific advice to the NRL and approval or otherwise should be provided by the States and Territories in which the competition is proposed to resume.
