**REQUEST FOR COMPARATIVE RESEARCH RELATING TO MEDIA
CONTENT AND CLASSIFICATION SCHEMES IN OTHER COUNTRIES**

I am writing to provide further information to the Senate Legal and Constitutional Affairs Committee's Inquiry into the Australian Film and Literature Classification Scheme following the appearance by the Department of Broadband, Communications and the Digital Economy before the Committee on 27 April 2011.

During the course of the hearing, the Department was asked whether it was aware of any recent papers similar to a paper written by Dr Jeff Brand of Bond University in 2003. Specifically, the Committee requested information on further research relating to a comparative analysis of ratings and classifications around the world.

The Department has identified three reports or articles which cover similar issues to Dr Brand's paper:

1. Freedom of Speech, Cinema and Censorship: a Comparative Analysis of Issues of Freedom of Speech Violations as a Result of the Rating Regulation Authorities in the Motion Picture Industry in France and the United States

This 2002 article compares the French and US classification boards. It examines the implementation of their decisions and reviews. The paper also explores the addition of an R18+ category and its potential impact in these countries.

2. Trends in media use by children and young people: Generation M2 2009 (USA) and MCAF 2007 and CPCLA 2009

It provides insights into trends and patterns of media use in youth, including mobile phone, internet, computer, and games use.
