**GENERAL COMMENTS**

Infosys Technologies (**Infosys**) remains committed to assisting the Joint Committee of Public Accounts and Audit (the **Committee**) with its inquiry and would like to thank the Committee for the opportunity to respond to its supplementary questions. The responses we have provided to the Committee reflect Infosys' understanding of the questions being asked on record and have been sourced to the best of our endeavours, noting the historical timeframe of the information being gathered.

**Question 1**

**1) Your previous responses to earlier questions detailed meetings between Infosys and former Minister Stuart Robert and noted that on 25 February 2022 Infosys executive met with then Minister Stuart Robert and Mr Scott Briggs for a “[d]iscussion of the challenges related to immigration visa and moving staff from overseas to Australia, as well as Infosys’ jobs and skills program. Infosys also provided a high-level update on the progress of the ECE program.”**

**a. What was the nature of Infosys’ relationship with Mr Briggs?**

**b. How many meetings did Infosys hold with Mr Briggs? (please provide details, including dates, locations, attendees and purpose of meeting).**

**c. Were representatives from Synergy360 present at any of these meetings, or included in any other communications Infosys exchanged with Mr Briggs?**

**d. Did Infosys have any discussion with Scott Briggs or other individuals about joining a pitch to win a federal government contract to outsource visa processing? If yes, what was envisaged to be Infosys’ role in this bid?**

**1a. What was the nature of Infosys' relationship with Mr Briggs?**

**Response**

Infosys began a commercial relationship with Australian Visa Processing (**AVP**) (which later became known as "SecureFast") in April 2018. At the time, Infosys understands that Mr Briggs was the executive director and founder of AVP and chief executive officer of Pacific Blue Capital, an investor in AVP. Infosys understands that he left the business in 2020.

Separately, Infosys engaged DPG Advisory Solutions (**DPG**) to provide advisory services to it and has been registered as a client of DPG on the Australian Government Register of Lobbyists, on 15 July 2021. Infosys understands that Mr Briggs was a partner in the business at that time.

**1b. How many meetings did Infosys hold with Mr Briggs? (please provide details, including dates, locations, attendees and purpose of meeting).**

**Response**

Infosys has reviewed its business records to identify meetings between Mr Briggs and Infosys in relation to the Digital Visa Processing Platform Tender and the Permissions Capability Tender (as those tenders are defined at the response to 1d. below). The information included in Annexure A is extracted from Infosys employees' (and former employees') calendars. Given the historical timeframe of this review, in some instances it is not possible to confirm if the scheduled meetings actually took place and who attended the meetings.

Infosys would also like to draw to the Committee's attention that in its supplementary question, the Committee has referred to a meeting on 25 February 2022 which was included in Infosys' response to the Committee's questions on notice from the hearing of 23 June 2023.

The meeting on 25 February 2022 was not related to the Digital Visa Processing Platform

Tender or the Permissions Capability Tender (as those tenders are defined at the response to 1d. below).

The purpose of the meeting was to discuss the challenges Infosys faced in securing immigration visas for skilled employees locating to Australia. Mr Briggs attended this meeting in his capacity a registered lobbyist.

**1c. Were representatives from Synergy360 present at any of these meetings, or included in any other communications Infosys exchanged with Mr Briggs?**

#### **Response**

Representatives from Synergy 360 were copied on email correspondence between Infosys and Mr Briggs in relation to the Digital Visa Processing Platform Tender and the Permissions Capability Tender (as those tenders are defined at the response to 1d. below).

**1d. Did Infosys have any discussion with Scott Briggs or other individuals about joining a pitch to win a federal government contract to outsource visa processing? If yes, what was envisaged to be Infosys' role in this bid?**

#### **Response**

In around September 2018, AVP selected Infosys to be a subcontractor as part of its response to the Department of Home Affairs tender for the design and build of a “global digital visa processing platform” (**Digital Visa Processing Platform Tender**). AVP envisaged that Infosys' role as system integrator would include program management, integration of the platform technology, and technological support services (application and infrastructure management).

In March 2020, the Department of Home Affairs terminated the Digital Visa Processing Platform Tender.

In October 2020, the Department of Home Affairs issued a new tender in relation to the

digitalisation of visa processing (**Permissions Capability Tender**).

AVP responded to this tender and its proposal outlined a subcontracting role for Infosys.  
AVP was not successful in this tender.
