How prevalent is underpayment of a legal wage...?

Answer:

In 2019, following the recommendations of the Migrant Workers Taskforce report, and an internal review, the FWO has revised its compliance and enforcement approach, and significantly increased its use of available statutory enforcement tools.

This approach has contributed to a large increase in wages underpayments recovered. Additionally, FWO's investigations of large corporate entities has led to an increase in the amount of monies recovered for employees in 2019/2020.

In 2019/20, the FWO recovered \$123.5 million for over 25,000 workers. This is three times the amount recovered in 2018/2019 and four times the amount recovered in 2017-18.
