the Australian higher education and research sector  
Submission from Macquarie University**

As such, we are pleased to see the level of attention and scrutiny the Government is applying to safeguard Australia and its research from potential risks of foreign interference.

As a leading Australian university, we acknowledge the integral role we play in developing and maintaining positive, productive and mutually beneficial partnerships with researchers and research institutions both in our immediate international region and further afield. We anticipate being able to contribute to the maintenance of reciprocal and synergistic relationships with partners around the world while minimising and mitigating any and all security risks posed by foreign interference.

We have been actively collaborating with Universities Australia to share best practice in our systems and processes and to learn from the experiences and successes of other universities. We are poised to work closely with relevant Government departments and agencies to further strengthen our risk mitigation strategies and to ensure compliance with the germane legislative and regulatory frameworks.
