## **Global College Chaos- What Students Should Do**

The NSW Government has cancelled all Vocational Education Training (VET) courses at Global College thus causing the Commonwealth Government to cancel the CRICOS registration for all VET programs. This means that students can no longer finish their VET courses at the school.

VETAB has suspended the ELICOS courses for the time being meaning that these students will probably be able to finish their courses.

## **Refund or ask Global to find you another course?**

Students have two major choices to make;

- 1) Ask Global College to find you another course (at no cost to you) or;
- 2) Ask Global College to provide you a full refund for the course you were studying.

Make sure whatever option you choose, put your request in writing and keep a copy of what you give them. Do not just ask them verbally, hand a letter to them and make sure you get their response in writing. If they offer you verbal assurances it would be best not to accept this alone, demand they put it in writing. In adopting this strategy will protect your best interests later on.
