MENTAL AND PHYSICAL ABUSE SHOULD BE INCLUDED AS I'M SURE THE SUFFERING THEY INDURED TURNED THEIR MINDS, AND MAYBE INTO CRIME BUT THEY SUFFERED FIRST, TO MAYBE RUT THEM ON THE ROAD THEY SUFFERED FIRST, TO MAYBE RUT THEM ON THE ROAD THEY ENDED UP ON. I ALSO WOULD HOPE THAT THE COMMITTEE CHAIRED BY SENATOR DERRYN HINCH, WOULD CONTAIN AT NEAST TWO MEMBERS WHO WERE SURVIVORS AS TO BE SURE THE COMMITTEE REALLY UNDERSTANDS THE SERIOUSNESS AND WHAT WE SUFFERED AS STATE WARDS ETC IN CHURCH RUN HOMES AND WORKING FARMS, PLUS FOSTER HOMES AND ANT OTHER PLACES THEY HAVE BEEN IN.

ALSO THE DREADFUL INDEA OF "INDEXATION", JUST SAY IT AS IT IS, IT'S JUST A TAX - A TAX ON COMPENSATION GIVEN TO THOSE THAT DESERVE IT - NOW JUST RIPPED OFF. GIVEN WITH A APOLIGY THEN RIPPED OFF WITH THE OTHER HAND JUST UNBELEINABLE YOU AS A GOUERMMENT COULD DREAM UP SUCH A SCHEME). WE HAVE TO WAIT UNTIL 2019 BEFORE OUR REDDRESS APPLICATIONS WILL BE ACCEPTED. THE NEXT BIG BETRAYAL OF ALL iS WHEN WE ABREED TO TALK TO THE ROYAL COMMISSIONER IT WAS ALWAYS TO BE STRICTLY CONFIDENTIAL - EVEN ON OUR REDORESS APPLICATION IT SAID WE MUST MAKE A PHOTO COPY IF WE WISHED, AS OUR STORIES WERE TO BE DESTROYED. NOW YOU WANT IT TO BE SUPPLIED TO VARIOUS GOVT. DEPARTMENTS AND TO THE CHURCH MONGRELS WHO WERE RESPONSIBLE IN THE FIRST PLACE NO DUTY OF CARE "
