### **SUBMISSION ON THE GREEN LOANS INQUIRY**

The Electrical Trades Union, Victorian Branch (ETU) currently represents approximately 17,700 members. Unlike the union movement generally, our membership has consistently increased from approximately 7000 in 1995. This membership growth is an indication of the high regard in which the ETU is held by workers in our industry. It is a reflection of the fact that the ETU is a progressive organization which has successfully looked after the interests of its members.

ETU members are employed in an array of industries. Some members work in carbon intensive industries such as petro-chemical, others in renewables. Looking after the interests of our members includes being aware of the changing landscape of employment opportunities, trends and policies.

With respect to the Green Loans Program, the ETU supports the intent of the program in that it was designed to provide a financial incentive for householders to undertake energy and water saving measures within their home. The program's design however did not directly tie spending with carbon emission reductions; this is a major failing.

The ETU supports the Green Loan program being redesigned. With this particular attention need to be given to:

- Providing a program which in time can be self sustaining, thereby preventing the boom and bust cycles that have recently occurred within the government's environment portfolio;
- Be simple to understand thereby maximising community confidence and participation;
- Have quality control measures put in place for both the training and assessment components;
- Ensuring all government spending results in the provision of education and actual carbon reductions;
