INTRODUCTION AND PURPOSE

Kakadu National Park is a site of international significance best summarised in the Park Management Plan.

Kakadu National Park covers an area of 19,804 square kilometres within the Alligator Rivers Region of the Northern Territory of Australia. It extends from the coast in the north to the southern hills and basins 150 kilometres to the south, and 120 kilometres from the Arnhem Land sandstone plateau in the east through wooded savannas to the western boundary.

Kakadu National Park is an Aboriginal living cultural landscape. A strong relationship exists between Bininj and their country, ongoing traditions, cultural practices, beliefs and

The living Aboriginal culture in Kakadu is diverse as there are many different clan groups with associations to country in Kakadu. Each clan group is responsible for looking after and speaking for particular areas of country in Kakadu, and this responsibility has been passed down from previous to present generations. The management and use of the land by past and present generations of Bininj has helped to shape the landscapes that we see in Kakadu today.

The Park is ecologically and biologically diverse. Major landforms and habitats within the Park include the sandstone plateau and escarpment, extensive areas of savanna woodlands and open forest, rivers, billabongs, floodplains, mangroves, mudflats, coastal areas and monsoon forests.

The value of the natural and cultural heritage of the Park to the world has been recognised by its inscription on the World Heritage List under the World Heritage Convention. The Park includes a large area that is listed as a wetland of international importance under the Ramsar Convention, and many species that occur in the Park are protected under international agreements such as the Bonn Convention for conserving migratory species and Australia's migratory bird protection agreements with China (CAM BA) and Japan (JAM BA).

The Mary River Precinct is the southern most of seven visitor precincts identified within Kakadu National Park.

The spectacular landscapes and iconic natural features of the precinct are of high cultural significance to the Jawoyn traditional owners.

A Visitor Experience Plan undertaken in 2014 by Parks Australia identified potential experiences for visitors to the Precinct.

The purpose of this development plan is to explore opportunities to provide the infrastructure required to facilitate and where appropriate, extend the range of experiences identified in the Visitor Experience Plan.

2 PROCESS


This development plan forms part of a long term planning process for the precinct the stages of which can be summarised as follows:

- Visitor Experience Plan
- Development Plan
- Site Masterplanning / Feasibility Analysis
- Site Detailed Design
- Implementation
- Review

The development planning process has included regular consultation with Traditional Owners and Parks Australia staff summarised as follows:

- Initial site visits and investigation
- Preparation of site analysis and option studies
- Consultation and site confirmation
- Revisions to planning studies

The Gunlom Falls Precinct was identified as a priority by Parks Australia. Masterplanning for the site has been undertaken in parallel with the development planning process including consultation with Traditional Owners.




3 CONTEXT

The Mary River Precinct is one part of the wider Kakadu National Park. The majority of visitors to the precinct will explore other sites within the park environment and it is important that development proposals integrate with the wider experience.

Many activities occur across the park (e.g. walking/camping) however individual precincts and landscapes are unique and provide unique experiences. Where possible development proposals should consider experiences that are unique to the precinct, park and wider visitor environments.

Indigenous culture is integral to any experience within Kakadu National Park. All proposals must recognise and respect the potential cultural impacts of infrastructure and activities.



3.1 Regional

Kakadu National Park is of national and international significance as a World Heritage Conservation Site and as a tourism destination.

3.2 Park

The Mary River Precinct contains iconic visitor sites however has lower visitation than the northern areas of the Park. It is considered that, with appropriate development, opportunities exist to encourage visitors to explore the differing landscapes of the southern region.

Precinct 3.3

3.3.1 Access

Access to and within the park and precinct is a significant issue for any development proposals.

High quality, all weather roads provide access to the park and within the park the Arnhem and Kakadu Highway link the major precincts. During the wet season (typically November to April) access to significant areas and sites is not possible or severely restricted.

While improvements to road standards can reduce the extent of the closure period significant areas of the park will remain inaccessible during the wet season limiting wet season experiences for visitors. It is recognised that the creation of wet season experiences has the potential to extend visitation within the park.

Within the Mary River precinct there are several sites that are accessible during the wet

The selection of sites and provision of infrastructure must also recognise the impacts of seasonal closure.

3.3.2 Environment

The environment of Kakadu National Park is of international significance. Development must occur in strict accordance with environmental guidelines. Future planning at individual sites will require consideration of detailed environmental issues and appropriate approval processes.

3.3.3 Culture

The cultural landscape and associated stories provide opportunities for the enhancement of experiences across the precinct.

The Jawoyn culture requires consideration of Sickness Country protocols in addition to the particular significance of individual sites. Areas within the precinct are accessible by permit only.

Wider historical influences include pastoral, exploration and mining sites. These sites create opportunities to broaden visitor experiences and often have connections to the lives of traditional owners.

4 EXPERIENCE PROPOSALS

Visitors to Kakadu National Park are provided with a variety of nature and cultural based experiences. These experiences range from the highly structured to highly independent however all reflect on the landscape in which they are based.

This development plan considers the experiences outlined in the Visitor Experience Plan (VEP) and has in some cases enhanced or expanded the experiences discussed in the VEP.

This section outlines the experiences as groupings of activities. Discussion of individual sites is included in Section 5 - Site Proposals

4.1 Touring

All visitors access sites using vehicles of varying types and this forms part of their experience. Travel times between points of interest are often extended and there is often little opportunity for the landscape to be appreciated outside of a vehicle. This has the impact of reducing the potential for a greater natural experience and the time spent within the precinct.

Proposals include the establishment of further points of interest on travel routes to increase the experience of the landscape, enhance touring experience and create additional attractions in the precinct.

4.1.1 Commercial Tour Operators

Visitors utilising the services of Commercial Tour Operators have access to a full range of experiences within the precinct. This includes access to controlled sites (e.g. Jarrangbarnmi) and sites that are not identified / promoted for general access.

It is noted that access to iconic sites is limited to 4WD vehicles generally and that coaches can only access sites on the Kakadu Highway.

4.1.2 Independent Travellers

Access to sites by independent travellers is limited only by permit requirements and use of a 4WD vehicle.

There are several sites within the precinct that are not promoted for use by the general visitor however can be accessed if the visitor has knowledge of the site. While this management method has restricted visitation in the past the information available via website is likely to increase usage over time.

The management of access to these sites should be resolved in the development plan and individual site proposals are discussed further in Section 4.



4.2 Day Visitor Activities

All of the sites within the precinct provide a potential experience to the day visitor. This varies from the iconic (e.g. Gunlom Falls) to the minor (e.g. Mary River Ranger Station).

The majority of sites within the park and precinct offer universal experiences for the visitor that may not be included in the specific categories outlined below. These universal experiences can include but are not limited to:

- Picnicking
- Viewing (scenic views)
- Birdwatching
- Contemplation / relaxation

While not requiring discussion as individual activities several may require infrastructure provisions and could be integral to the experience of most sites.


4.3 Walking

The majority of experiences within the park and precinct require visitors to utilise walking trails of varying standard, difficulty and length. There are very few sites where the experiences are available immediately on leaving the vehicle and this should be maintained and in some cases extended.

Walking trails across the park are subject to a separate, comprehensive strategy and process. This strategy includes proposals for multiday walking routes. The provision of access for mountain biking is in the early stages of consideration.

This report will comment upon specific opportunities identified at particular sites however will defer to the walking strategy regarding larger scale proposals. It is noted that trail heads are generally poorly presented and identified. Future Masterplanning and signage projects should address this issue.

Walking Site Locations






4.4 Swimming

The unique swimming opportunities within Kakadu National Park are attractive to visitors. Within the precinct this experience is available year round at Motor Car Falls (via Yurmikmik) and Ikoymarrwa (lower Moline Rockhole). A seasonal experience is available at Gunlom and Maguk.

These opportunities require management due to crocodile hazards and the potential for environmental damage.

The current swimming experiences are to be maintained and are discussed on a site by site basis. Additional swimming experiences are not proposed.

4.5 Accommodation


Serviced Accommodation is provided across the park however is unavailable within the Mary River Precinct.

Limited accommodation is provided at the Mary River Roadhouse however this site is outside of the Park boundary. The roadhouse site presents opportunities for accommodation and other commercial development and has the advantage of available services and freehold ownership. Its current service provision is not considered to provide a major accommodation service to visitors to the park. It has the disadvantage of not having a memorable environmental setting.

A comprehensive analysis of accommodation provision in the precinct, park and region has been prepared by Savills and is included in the appendix. This analysis suggests that opportunities exist for 4 to 5 star accommodation in all-weather sites. Other accommodation types are generally available elsewhere in the precinct.

For the purpose of this report two categories of accommodation are considered and discussed below. The form of construction does not define the accommodation type which is based upon the level of service provided to guests.

It would be expected that higher levels of service will require higher levels of infrastructure and permanence.



Accommodation Site Locations

4.5.1 Serviced Accommodation

Serviced accommodation may take many forms and provide various levels of service at differing standards. It is assumed that serviced accommodation provides as a minimum:

- Quality rooms (probably air conditioned)
- Individual bathroom facilities
- Meals service (either restaurant or in room catered)
- On site staff

It may also provide higher levels of service including:

- Restaurant / Bar / Lounge
- Pool / Day Spa

and other elements associated with resort style facilities.

This standard of accommodation requires significant capital expenditure.

To attract quality investment identified sites would have year round access and preferably a quality site environment with natural environmental and cultural features (e.g. views, storylines). Potential sites have been identified at Mary River Ranger Station and Bukbukluk and are discussed further in Section 5.

• Confirm process and methodology for consideration of future development of sites.

'Safari Camp' Accommodation

For the purpose of this report safari camp style accommodation is considered to have the following characteristics:

- Non-permanent construction (e.g. tent structures)
- Shared bathroom facilities (generally)
- Informal 'camp kitchen' style catering
- Limited service areas and activities

The standard of service provided within a 'safari camp' may vary and a high level of service would be possible.

It is assumed that the more transient nature of this accommodation style will require a lower capital investment. Seasonal sites would therefore be considered appropriate and a lower occupancy rate is possible dependent upon the business model of the operator.

Specific sites have not been identified. It is anticipated that sites would be considered based upon approaches from commercial interests.

• Confirm process and methodology to inform proponents of the potential for this development type.

4.6 Camping

Camping is an integral experience for many visitors to Kakadu National Park and sites are dispersed through most precincts.

Within the park and precincts camping areas are categorised as "managed" (camp host during peak) or "unmanaged". Both campground categories are present in the precinct.

Gunlom is the largest and most popular campground due to its setting and location on an iconic site. Lower levels of service are provided at other campsites within the precinct.

Camping is undertaken by both independent travellers and tour groups. For the purpose of this report "group camping" is defined as self-contained tour groups who utilise available site infrastructure only (not Safari Camp Accommodation - refer above).

At present there is limited information on occupancy rates available for camping. It is generally considered however that additional campgrounds are not warranted (additional management / maintenance requirements). Opportunities for additional campsites are identified within specific, existing sites as discussed below. Removal of camping from Ferny Gully is proposed.



4.7 Fishing

Fishing and boating in waterways within the precinct is currently not permitted. A review of fishing and boating is identified under the new Management Plan and may change access arrangements within the precinct in the future.

4.8 Administration / Visitor Services

The Mary River Ranger Station is the administration base for the precinct providing offices, workshops and ranger housing.

Visitor services are provided with limited access available to an unmanned visitor display both internally and externally.

At present the site has no other visitor attractions. A potential high quality cultural walk has been identified on the edge of the escarpment. Subject to Sacred Site clearances this walk could extend the current function of the site. Other walk opportunities may also exist.

Due to the presence of service infrastructure the site has significant potential as a location for a visitor hub or accommodation. This potential is outlined further below. Development proposals for the site should await the outcome of Accommodation proposals.

4.9 Rock Art Viewing

There are currently no sites within the precinct where the viewing of Jawoyn rock art sites is facilitated.

Consultation with traditional owners has suggested that opportunities may exist to appropriately provide this cultural experience to visitors in accessible locations (e.g. Mary River Ranger Station).

This opportunity can only be explored after a comprehensive consultation and approval process.

Actions:

• Commence consultation and site identification process.



5 SITE PROPOSALS

A range of infrastructure development will be required to enhance existing infrastructure and cater for new experiences as identified in the Visitor Experience Plan (VEP).

This development may occur at individual sites, geographical groupings of sites or in the entire precinct.

This report outlines potentials for development. It must be noted that all proposals for all sites will require further development prior to final implementation. The feasibility of each proposal would also be tested during future planning phases.

It is assumed that all development proposals would be pursued to a high standard. The VEP nominates six criteria for progressing experiences. These criteria are equally appropriate to the proposals contained in this development plan.

- Meeting the Guiding Principles in the Shared Tourism Vision
- Allowable under the 6th Management Plan
- Consistency with the Tourism Master Plan
- Likely to appeal to the target markets
- Consistency with lawoyn traditional owners wishes for the area including Sickness Country Protocols
- Likely to be sustainable both from an environmental and business perspective

In addition the following criteria will be considered:

- Appropriate to the character and physical nature of the site
- Development of sites within the precinct occurs within the context of Kakadu National
- Development proposals must consider and incorporate across park planning and infrastructure standards (e.g. Facility Manual, Walking Trail Strategy, Signage)

During the consultation process other potential sites were discussed. The specific location and nature of the sites was not sufficiently detailed to allow either a site visit or identification (e.g. Picaninni Pocket). They are therefore not included in this report. If future development is considered it should occur in the context of this Development Plan.

5.1 Existing Sites

The majority of development proposals will consider improvements to experience quality at existing visitor sites within the precinct.

5.1.1 Maguk

The Maguk site provides a swimming experience in a waterfall setting at the end of a short walk in a high quality landscape setting.



The existing camping and day visitor areas at Maguk will be retained and improved (Refer drawing 15005-sk 30). Detailed planning should be undertaken to provide:

- Improvements to campground.
- Improved day visitor parking and picnic area.
- Improved links between camping and day visitor areas / falls.
- Determination of the viability of the access trail to the upper level at the falls.
- Improvements to pedestrian safety where practicable.


- Assess viability of upper levels access.
- Masterplanning.

5.1.3 Gungurul

The Gungurul campground is located at the end of a sealed all-weather access road. It also provides a trailhead for two short walks.

The campground does not provide a high degree of amenity and due to its location has limited potential for expansion.

The quality of the access road would facilitate use for a serviced accommodation site however the landscape and setting is not considered to provide the quality of experience available elsewhere in the precinct.

Improvements to the site could include:

- Detailed improvements of camping sites focusing on larger vehicles (e.g. caravans,
- Should demand warrant, additional camping sites along the access route could be considered.
- Detailed improvements to the presentation of the site and trailhead.

Actions:

• Improvements to infrastructure / presentation.

5.1.4 Bukbukluk

Bukbukluk provides high quality panoramic views across the landscape at the end of a short walk. All weather access is available.

There are two potential options for the site.

Option I

Improve and retain the site as an all-weather day visitor location providing exceptional views

Option 2 (Refer drawing 15005-sk 24)


Due to all-weather access, high quality landscape and views the site has potential for serviced accommodation. Should this option be pursued an alternative site for day visitors to experience the scenic views currently available would need to be investigated. Site experiences would be compromised for both user groups should collocation be attempted.

Actions:

• Determine process for identification of commercial accommodation site.

5.1.5 Gunlom Falls

Gunlom is an internationally recognised iconic site. The clifftop and lower level pools offer visitors unique experiences of the landscape. It is only accessible during the dry season.

The site accommodates a large, serviced, managed campground and day visitor facilities. Short walks are available to the clifftop pools and Murrill Billabong / South Alligator River.

While there has been investment in the infrastructure at the site it is recognised that site planning and site quality require improvement.

The traditional owners have requested that the site not be considered for serviced accommodation requiring intensive infrastructure. The seasonal nature of site access and susceptibility to inundation is also likely to limit the potential for intensive commercial development.

Future development of the site would include:

- Improved day visitor facilities.
- Improved campground facilities.
- Consideration of potential for a safari camp location (at a distance).
- Consideration of new and extension of existing walking trails (Billabong and Pool) to create loop walk opportunities.

Detailed planning of the site has been the subject of a separate Masterplanning process. Three options for development were prepared and presented to the traditional owners (refer Appendix). A preferred option was identified and masterplan prepared.

The masterplan drawings are included here and represent a higher level of planning and consultation (refer drawings 15005 -sk 37 and 15005-sk 29). The key proposals of the masterplan are as follows:

- Removal of vehicle traffic from the day visitor zone.
- Reduction of the visibility of infrastructure from the cliff top pool through the removal of carparking and increased planting.
- Location of clearly separated day visitor and camping use and traffic zones.
- Comprehensive replanning of camping areas to provide an improved accommodation experience through defined and separated campsites.

Redevelopment is assumed to enhance and extend the quality of site experience through improvements to interpretation, infrastructure and environment.

- Masterplanning (complete).
- Implementation.





5.1.6 Jarrangbarnmi

Jarrangbarnmi (Koolpin Gorge) is located on a south-facing part of the main escarpment on Koolpin Creek. Access to Jarrangbarnmi is by permit only via the road to Gimbat and on a four wheel drive track of approximately 11 km. The gorge and surrounding country are noted for their beauty and scenery as well as the high incidence of rare/endemic plant and animal species.

The site was not visited however it is not anticipated that use or access would change.

Staff advise that general improvements to site planning and facilities are required.

Actions:

• Site Planning

5.1.7 Gimbat / Guratba

Gimbat provides an un-serviced picnic experience at the end of a scenic drive along the South Alligator River. With the exception of the remnant road infrastructure and access to the river there is little to differentiate this site from many other locations.

There are however many points of interest, cultural story-lines and historic mining sites on the access route and the potential of this locality is discussed further below.

Actions:

• Refer South Alligator Valley Road discussion below.

5.1.8 Yurmikmik

The Yurmikmik site is a trailhead for walks to Motor Car Falls, Boulder Creek, Yurmikmik Lookout and greater Kambolgie circuit overnight walk. The walking routes are established with detailed improvements to be considered over time.

A planned upgrade to the Kambolgie Creek crossing will provide year round access in the

The carpark and trailhead are very poorly presented and require redevelopment to incorporate:

- Improved capacity.
- Improved trailhead.
- Defined and improved picnic area.

Actions:

• Site Planning.

5.1.9 Kambolgie

The Kambolgie campground provides an alternative, overflow accommodation site to Gunlom Falls providing a year round camping facility for visitors to Yurmikmik. The existing site is serviceable and improvements could be implemented however it is not sited within a memorable, destination landscape.

The investigation of expansion options can also occur. The replanning of the Gunlom Campground and the establishment of a clear capacity limit may require use of Kambolgie as an overflow / alternative camping location.

Traditional Owners have identified the site as a possible location for a Safari Camp.

Actions:

• Site planning recognising the links with Gunlom at peak use periods.

5.1.10 Ferny Gully

Ferny Gully is an attractive and environmentally unique, sensitive landscape predominately utilised for limited pre-booked camping by permit.

Management of the site relies on low visitation perhaps resulting from the lack of site identification and promotion. The current camping site occupies the prime site attraction resulting in degradation. Sustainability in this location is questionable.

This issue requires resolution prior to further development occurring at the site. Traditional Owners have confirmed a preference for Commercial Tour Operators access and limited independent traveller access on a restricted basis. The removal of camping is supported.

The site does have potential for visitation however changes to current access to visitor areas would be required (Refer drawing 15005-sk 31). Proposals include:

- Removal of camping.
- Establishment of the site as a recognised day visitor site.
- Creation of a walk to the points of interest from a trailhead/carpark located at a determined distance.
- Creation of a walk from Mary River Ranger Station (refer discussion below).

- Confirm and implement management proposals.
- Site planning.

5.1.11 Ikoymarrwa Lookout

The roadside lookout provides minimal parking and amenity from a small layover. The limitations on access created by topography are noted and expansion is not considered feasible.



5.1.12 Ikoymarrwa Rockholes

The top and bottom Moline rockholes are both attractive sites at the southern most end of the park. Swimming is available year round at bottom Moline. Both sites are not promoted to the general visitor and are therefore accessible through licensed Commercial Tour Operators or anecdotal / local knowledge.

The accessibility, promotion and management of both sites requires confirmation prior to further development.

Options for development are outlined below and diagrams illustrate these alternatives.

Option I (Refer drawing)

Upgrade existing experiences

- Development at bottom Moline to manage visitor numbers at the pool including relocated car parking.
- Investigate a short loop forest walk to the pool.
- Development of a Class I walking trail at top Moline including appropriate vehicle parking off the Kakadu Highway.

Option 2 (Refer drawing)

Create a new all year destination within the Mary River Precinct


• Examine potential for integrated parking and walking trails connecting the two sites.

- Confirmation of access / management.
- Masterplanning.

5.1.13 Mary River Ranger Station

The Mary River Ranger Station is a highly serviced, predominately administrative site located at the southern end of the park.

Visitor services are limited to access to unsupervised internal and external interpretive displays (in need of renewal) and the provision of amenities.

The site is the administrative hub for the precinct and provides good quality:

- Administrative office space.
- Workshop and storage.
- Ranger housing.
- Contractor bunkhouse.
- Services infrastructure.

The majority of the site has limited natural attractions however the potential for a high quality cultural walk to the west has been identified. Good quality distant views are available to the west.



There are several potentials for the Mary River Ranger Station site.

Option I - Minimal (Refer drawing I 5005-sk 22)

- Retain services as existing.
- Include a walking trail to the potential cultural site to extend day visitor potential.
- Establish as a visitor hub with inclusion of a cultural walking trail, walking trail to Ferny Gully, improved interpretive facility and possible commercial services (e.g. seasonal kiosk).


Option 2 - Accommodation (Refer drawing 15005-sk23)

- Establish serviced accommodation to take advantage of clifftop views to the west and the potential cultural trail (various formats possible).
- Relocate visitor hub and retain administrative use in existing location.
- Establish walking trails as per Option 1.

The presence of site infrastructure including power and water provides significant pragmatic benefits to any site developments that would require these services.

Actions:

• Determine process for identification of commercial accommodation site.

5.1.14 Mary River Roadhouse

The Mary River Roadhouse is located outside of the park boundary. As a freehold, serviced site it has potential for further commercial development. The site suffers from the lack of a unique setting when compared to other potential locations within the park.

This report cannot offer comments beyond those above as any future improvements / development of the site is dependent upon the property owners / leaseholders.

Parks Australia may be able to encourage appropriate development of the roadhouse however ultimately have no control over the type, availability and consistency of services provided from the site.

It should be noted that commercial development within the park and precinct has the potential to impact upon the feasibility and viability of any development at the roadhouse

5.1.15 Old Goodparla

The former pastoral site at Old Goodparla is of historic interest. Remnant structures and vegetation provide reminders of the pastoral lifestyle. The site is currently used by Commercial Tour Operators in the dry season. Should further public access be considered improvements could include:

- Preservation of historic structures.
- Provision of walking trails.
- Consideration of birdwatching or other environmentally based activities.
- Upgrade of access track.

Actions:

- Confirm access limitations.
- Undertake preservation of historic sites.

5.1.16 New Goodparla

This site was not visited however it is not considered to be of high importance due to limited accessibility and potential.

5.1.17 El Sherana

The remains of the former mining camp at El Sherana are not accessible to the public due to unresolved asbestos contamination issues. Limited access to the weighbridge is available however is not highly visible. Opportunities for further visitation should be pursued as part of a wider experience as discussed below (South Alligator Valley Road).

Further development would be dependent on resolution of contamination issues.

- Masterplanning / site identification.
- Interpretive planning.

5.1.18 Bloomfield Spring

Not visited.

5.1.19 Callanan's Hut

Callanan's Hut is a historic remnant of pastoral and mining use located on the banks of the South Alligator River off the Gunlom Road.

While currently unidentified the site has the potential as a point of interest (refer General Touring discussion). In addition to the historic relics it also offers the potential to access views to the South Alligator River.

- Preservation works.
- Site planning.

5.2 Proposed Sites

The identification and development of additional site locations to extend and improve visitor experiences can be considered. Proposals for future experiences and associated development are outlined below.

5.2. South Alligator Valley Road

Visitors who choose to visit Gimbat / Guratba travel along a diverse 4WD route that includes high quality landscapes, cultural sites and story-lines, small scale environmental experiences and historic mining sites. Many of these features would only be apparent if accompanied by an experienced guide. While the Gimbat site is not of destination quality the diverse experiences offered by the access route have visitation potential.

The creation of a "South Alligator Valley Scenic drive" would be possible and build upon:

- High quality, diverse landscape.
- Jawoyn cultural sites and story-lines.
- European history (Leichardt, Pastoral, Mining).

This would require the development of infrastructure at appropriate points of interest along the route (Refer drawing 15005-sk 32).

These could include:

- Mining site interpretation.
- Short walks.
- Cultural sites.
- Environmental sites (e.g. rivers, rare plants).

The potential for establishment of a Safari Camp could be considered.

It would be envisaged that the experience would be either guided or self-guided however would have sufficient points of interest to be promoted as a visitor destination.

Actions:

- Masterplanning / site identification
- Interpretive planning.


5.2.2 Termite Mound Site

Termite mounds are a significant feature of the Kakadu landscape. At present they are available for inspection by visitors informally without interpretation or control. It is proposed that a site or sites with all-weather access are identified and developed for the sensitive viewing and interpretation of these important landscape elements.

Potential site examples include the Kakadu Highway or the Maguk Access Road.

Actions:

- Potential site identification / Masterplanning.
- Site planning.



5.2.3 General Touring

Visitors cover large distances within the park and precinct to reach the iconic visitor destinations. Travel times between sites are often significant and appreciation of the landscape often only occurs from the vehicle. This is in part due to the lack of identified points of interest.

In the north of the park this is accentuated by the vegetation "tunnel" that conceals the wider landscape. The Mary River Precinct offers a different touring experience due to the more "open" landscape.

It is proposed that points of interest on key routes are identified and established to:

- Extend the visitor experience.
- Allow safe egress from vehicles.
- Allow more intimate appreciation of the landscape / views etc.
- Provide respite from longer travel times.

The termite mound site is an example of this experience.

On the Gunlom Road sites could include:

- Opportunities to view the South Alligator River
- Identification of appropriate environmental / cultural sites.
- Callanan's Hut
- Landscape view
- Short walk

Actions:

• Site identification / Masterplanning.

6 DEVELOPMENT PRIORITIES

There are a wide range of development and improvement opportunities identified in this Development Plan. It would be anticipated that implementation would occur over an extended period of time however it is possible to identify development priorities.

The sites below are grouped in the three categories of High / Medium / Low. While detailed priorities can be considered it is likely that development timing will occur based upon a variety of factors that may change over the short term (e.g. funding opportunities). Priorities within each category will exist however are less significant for the purposes of this report. The groupings below have considered a variety of factors including:

- Visitor experience benefits.
- Site conditions.
- Priority works (e.g. heritage preservation, environment protection).
- Process time frames.

It should be noted that while some sites may be indicated as higher priority it would not be anticipated that development activity on site would occur for some time due to the degree of investigation and planning required.

7 INDICATIVE DEVELOPMENT COSTS

Preliminary order of cost estimates have been prepared by Rider Levett Bucknall for fifteen of the sites discussed in this report. These costings, with the exception of the Gunlom Falls Precinct, should be regarded as preliminary "ball park" only. They have been prepared based upon:

- Undefined scope
- Limited site information
- Notional interpretive content scope

Cost opinions therefore represent order of costs that should not be used to formulate project budgets. They do however provide indicators that reflect the knowledge of the Consultant Team and could be used to:

- Assess priorities for future planning and development
- Determine capacity / limits for capital expenditure
- Inform the development program

Cost Opinions include elements required to provide a notional project cost. Including:

- Development cost
- Interpretive allowance (sign based system costs can vary significantly)
- Contingency allowance
- Professional and statutory fees allowance
- Locality Loading (development costs are based upon a notional "capital city" rate. This allowance provides for regional and locality factors)

These estimates indicate development costs for the fifteen sites in the order of \$12 million to \$15 million (excluding GST).

A costing summary is included in the Appendix. This summary includes brief descriptions of notional scope on a site by site basis. Masterplans for each site should be prepared to refine scope and cost parameters. This has occurred in master planning for the Gunlom Falls Precinct.

The costs associated with major accommodation proposals at Mary River Ranger Station and Bukbukluk are excluded. These costs will be entirely dependent upon the scope, type and method of development (e.g. there may be no capital costs incurred by Parks Australia).





Mary River Development Plan





quality of accommodation available

The quality of experience offered drives the quality of accommodation required.

The Mary River Precinct Visitor Experience Plan

The plan identifies a range of experiences and holiday activities available and we have matched the quality of accommodation suitable to each.

The list of visitor experiences promoted and available at Mary River is enough to justify 3-4 star accommodation and which would, given acceptable visitor access, go a long way to increasing visitation. At present the quality of accommodation is too rudimentary for some guest segments and the depth of the market can only be estimated by association to the more popular Kakadu Region.

accommodation size and style

The general Northern Territory experience evokes a sense of adventure, wonder and unique experiences unmatched anywhere else in Australia. This experience should be accessible to all levels of the travelling market place. The chart in the previous section showcases the broadness of appeal. It also suggests that it is relatively easy to cater for all groups if a well-planned approach is adopted.

It is likely the activities and nature based experienced travellers do not have a high expectation in terms of accommodation providing all basic requirements of hygiene (facilities), water, access and food services are available. The use of cabin style accommodation and tents cater adequately for the visitor segments which currently are attracted. The benefit to providing upmarket addition to accommodation is to attract a new segment who will pay more to enjoy the experiences on offer.

This segment largely do not participate due to the basic level of accommodation. An attractive, appealing, higher end accommodation facility will attract this audience.

4 to 5 star quality accommodation will deliver the necessary comfort experienced by this segment of the market. Initially developments should be encouraged at the 30-50 rooms, but with the ability to expand when full demand is known. Room size of 22-30 square metres and a central efficient relaxation guest area with food and beverage service will be required to service guests.

The quality lodge style model is likely to be ideal with an amount of accommodation and all services in a central core building and supplemented by high-end villas.

The range of accommodation options offered at present is best defined as follows;

- (A) No Booking System park-run campsites (first come first served)
- (B) Caravan Park accommodation (powered van sites)
- (C) Backpacker Share accommodation
- (D) 2-3 star Motel accommodation
- (E) Lodge style accommodation
- (F) 4 star Hotel
- (G) Safari accommodation

The Safari concept is appropriate to the countryside, the experience promoted and it's likeness to other similar experiences elsewhere in Australia and globally. It is limiting and the notion of safari living is not for all guests. That is it caters to a specific adventure seeking group, but is not suitable to a broader customer group such as retirees, or luxury seekers.



market place evaluation

There appears to be demand for accommodation at the mid-range level in the Mary River Precinct. The vast majority of accommodation available in the precinct is small scale, basic, tent and cabin based with a focus on being part of the environment and experience of the Northern Territory.

Kakadu is the main area where resorts of a reasonable size exist which are more universal in appeal to all market sectors.

Managing the seasons and being in control of labour to deliver service explains the mainly smaller places.

There is a need to discuss specific issues which will directly affect success, commercial viability and address seasonality. They are as follows:

Location Issues

There is road access to areas of the Mary River Precinct all year round. Whilst the wet season is quieter it still presents an opportunity to create a wet season experience providing access is available. The Kakadu Highway into the park to the Information Bay, Ranger Station, Bukbukluk and Gungural is the only access road all year round. It would be sensible to consider locations on or close to this highway to ensure maximum use and visitation in all seasons.

Seasonality

The defined wet and dry season not only affects access but also thought should be given to higher ground locations and natural catchments for services and facilities.

Services

Essential services such as power, telecommunications, water supply, waste removal and road access and car parking are best considered first by considering access to anything that currently exists or secondly by extending off existing supply. This will always mean a quicker, easier and more cost effective outcome.

The increased costs associated with 'greenfield site' developments must be considered.

Aspect

Whilst the above considerations are practical, the aspect of any 4 to 5 star development must be appealing.



competition

The competition to win business is driven by smart packaging which creates a more efficient forward booking environment. This helps efficiency and commercial profitability.

The experiences offered to create and gain bookings are essentially the same for each accommodation provider but are marketed in different ways to win business.

Most of the operators maximise the luxury component despite lower build quality of the accommodation. It is more about making the experience.

There is a real opportunity to create accommodation which expands the limited low level supply available.

At the present time, Jabiru, South Alligator and Cooinda Centres are the significant players in the region in terms of attracting the widest selection of visitors and will be the main competition to any development contemplated in the Mary River Precinct.

There are no high end facilities at present at Mary River Precinct. Whilst there are no demand studies which specifically support the creation of new facilities, the anecdotal evidence available suggests that if careful consideration is given to access and location a quality facility will be commercially viable.

The majority of travellers to the Kakadu Arnhem land region were visiting the region for a holiday (67%). There were also a significant proportion of business visitors (20%) and smaller numbers of VFR visitors (8%). There were also some visitors who visited the region for other purposes including employment, education or as a point of transit (4%).

The majority of international visitors were youth visitors, with over half (53%) aged under 40 years. The majority of interstate visitors are aged over 40 years (83%) and the intra-territory visitors are much likely to be aged below 40 years (66%).

There are eleven (11) establishments in Kakadu Arnhem region. Annual room occupancy for 2014 was 35%. Revenue per room occupied (RevPar) was \$53 per room.

During the peak season, ie September quarter, the room occupancy peaked at 58% and the RevPar rate was \$92.



site identification

We have been advised of two potential sites identified for development.

Site 1 is identified as the Mary River Ranger Station Site, located off the Kakadu Highway and in use as Administration, Ranger Housing, Workshop and car parking. The site already has an element of defined access and some services.

Site 2 is identified as Bukbukluk Site and is located also off the Kakadu Highway approximately 15 kilometres north of the Ranger Station Site.

Mandatory Site Requirements

The suggestion and recommendations are that development should be permanent not transient or camp style. In order to achieve market interest it is necessary to ensure that any site chosen can be developed readily without major delays or hurdles.

Any new tourism development will require;

- Access to site
- Water supply (on-site)
- Power (generator, solar etc)
- Waste solution (sewerage disposal plan)
- Clearance on development capacity
- Tenure on site (min to attract/spend capital)
- Central to attractions
- Available labour source
- Stakeholder approvals in place
- Defined area (boundaries)

We have considered 8 categories which contribute to site selection to arrive at a score out of 10. This process helps to assess the merits of both sites. Site exposure and creativity are subjective categories which consider which site will create a better experience in the long term.

We have reviewed each site in respect of basic parameters; The sites have been scored out of 10 on the listed parameters giving a total score out of 80. Some parameters such as water, power and waste will automatically attract zero scores where there is no provision at present. Equally Site 2 attracts a zero score where no buildings exist.

The above table indicates that Site 1, the Ranger Station Site is preferred. However when looking carefully at the scores this is purely a function of existing infrastructure.

site identification (cont.)

Questions require answering on the infrastructure. The Ranger housing (6 dwellings) would be a potential advantage to a developer enabling a rapid start to a first stage. Is the Ranger Housing available to a developer? Is there an additional cost or an expectation of purchase by a developer? The answers to these questions may influence the scoring of the site. Equally the power, water and waste services may be adaptable or may be of no great value to a larger development. Answers to this question will affect the score.

Site 2 is a better site from an aspect and uniqueness perspective. It fits the brief to create an experience which is magical and private. The question of water supply, waste removal and power should be relatively easy to establish a position on but this must be carried out immediately before a choice is made.



next steps

If the issues of water, waste and power are resolved for Site 2, then consideration should be given to offering both sites to the market under an expression of interest process. Any marketing should be prescriptive in terms of required development, ie Hard Build Structures with minimum pod style accommodation, ie not Safari.

It is preferred to present a package indicating the fundamental requirements to develop another site are resolved and focus developers attention on the opportunity and their creativity to develop.

If no one shows interest the opportunity should be shelved and perhaps re-offered at a later point rather than drift down to a much lesser option.

The Marketing process involves creating a high quality full colour document for hand and digital circulation showing the attributes, opportunity and requirements to be involved. Headings need to include;

- Location

The invitation should be in the market for around two months to allow parties the opportunity to consider, visit and investigate.



conclusion

At present Mary River Precinct offers visitors a unique Northern Territory experience. Mary River Precinct is not as developed as the rest of Kakadu but nevertheless deserves consideration as a destination worth promoting for greater tourism focus and investment. The safari or camping experience is the main accommodation style. This is consistent with the tough demands created by a defined wet/dry season and low/high season for visitors. Sites should in the first instance be considered on or just off the all-weather road access currently available to maximise guest stays and reduce costs related to any development contemplated.

Whilst there is a lack of market demand evidence there is ample anecdotal evidence that a broader market appeal accommodation development would be a success.
