## **ABOUT LIVE EXPORTS (others matters section 3)**

**MEDIA, Industry Lobbyists, , have misrepresented issues relating to Australia's inherently cruel and economically destructive live export trade.**

Clarifying the context of this submission, I would like to advise the Committee that I currently have no pecuniary interests in primary industries to declare. Furthermore, I believe it to be in the interests of all Australians that all issues surrounding live export should be exposed; which, thanks to selective reporting by the media, has not happened thus far. In my opinion this has denied the people of Australia access to central and critical elements of the live export debate. I work with many people and several organisations. I do not receive any remunerations from anybody. I am interested in the best for Australia's agriculture, our farmers and Australian farm Animals, our economy and jobs.

My experiences over the last ten years trying to get the media in Australia to report the truth about live exports are very relevant to this inquiry. The first matter I wish to raise may have a direct effect up the outcome of the findings to this Senate Inquiry into live exports.

So I will raise that first matter, then move down a long list of my concerns as to how media proper- gander has distorted honest reporting about the live export trade.

This was sent to me through a reliable source.=

### **Matter One- THE PLAN= &**

Not long after receiving the PLAN just as promised I saw the cattleman threatening the Prime Minister and Minister Ludwig through the media

that they were about to start shooting cattle. We must remember that the ban was only in place for about \*three weeks at that time. These people are often delayed longer, for many reasons- eg floods.. Therefore it is inconceivable that they haven't been held up before, and not shot cattle. If however I am to be proved wrong then this must surely be enough evidence to the inquiry that its a unsustainable industry which requires diverting to chilled or dry meat.

I have sat back and watched everything I was told was going to happen, played out through the media. I believe this was a big part in the Government resuming live exports. Of course it was. After all that is what it was intended to do, ~ that was- is the plan.~

### *– History shows the PLAN worked-*

I did assist I believe to ward off the dumping of two thousand head of cattle at Parliament house lawns. That yet again displays the bullying mentality of industry and graziers. Needles to say utter lack of concern for animal welfare:

I can assure this inquiry the information about the medias and industry role in the PLAN comes from the heart land of the industry and graziers. The person who wrote this to myself is educated and very much in contact with main players. I had also had several conversations on the phone and there is no misunderstanding about why they used the media and threatened to shoot the cattle what so ever in my mind. I was advised not to be seen to contribute to this senate inquiry or to support the banning of live exports. I believe it was sent with 100% good intentions towards myself. The message was clear urging me not to be seen supporting RSPCA ,4 Corners and Lyn White Animals Australia or the Senators to Ban Live exports .

The PLAN did work and the fact the Minister and Prime Minister no doubt were under enormous pressure resumed the trade. This has been a grave mistake for many reasons. While I do understand, the fact remains, as promised media played a huge role in the PLAN. Resuming the trade has only achieved to get both sides cheesed off with this Government.

Prestunning is not mandatory and the cruelty will continue. So too will the hundreds of thousands members of the public ( & growing) and Animal welfare organizations both in Australia and worldwide to keep this in the spotlight and rightfully so.

**The FULL PLAN.- working industry with Media exposed –**

**What I was trying to convey to you was the *perception* of the producers and even farmers in general, of the situation at the moment.**

**Those perceptions are built from what they read, hear and see in the media. Perceptions can easily be turned into belief and the *truth* by those practised in the media. **I have been in the media business for long enough to know how it is done. It is the strike back from the vested interests in the live trade. Had I been advising them I would have given the same advice. Discredit your opposition. When you have time get a DVD called 'Wag the Dog'. Then you will understand the world I understand. We might get on the same chapter next?**

**I regret you found it necessary to be patronising. I realise you are tired and under extreme pressure. I am a working retired. I shall keep doing what I am good at.**

**Just today I was asked to give an opinion on what the structure of a future northern cattle industry should be? The sub-question was: Does it have a future? At the most 3% of the Australian cattle industry?**

**As I understand it:**

- 1. You and your colleagues have as a business objective to set up cooperative arrangements with livestock producers to develop either with existing abattoirs or by developing new abattoirs to provide Hal Al meat for domestic and export markets.**
- 2. You (Ha Al Kind Meats) also have a record, a history, of cooperating with the RSPCA, Animals Australia et al, to stop the live export of Australian livestock.**

**Let us now turn to the current situation. Livestock producers across the country are very angry. They are of the view that the 4 Corners programme was a set up.**

**They do not believe that the RSPCA and Animals Australia have been honest. They are of the view that the footage shown on television was both old and fabricated. Rumours and accusations abound. The conspiracy theorists are having a field day.**

**Those views of manipulation of the facts are shared by some politicians. There will be an enquiry. It will take months of deliberation. The truth may never be determined. If the RSPCA and AA are censured by a Senate enquiry it will bode ill for the anti live animal export lobby.**

## Matter Two

**Another example of how the INDUSTRY Blocks Farmers and Graziers from \*hearing from buyers with alterative markets just \*two days ago=**

I contacted the cattlemen's Association regarding the feasibility studies for abattoirs in WA & NT. I explained I had been speaking with Federal Government in WA and I had delegates very interested to travel to Australia with a view to meet producers, farmers to discuss the best approach to put in infrastructure and open abattoirs.

They said no problems just give Agforce a call because that's what they do- they often show people around and make introductions to growers etc and we know there are a group of growers very interested to have new abattoirs built and always happy to meet with new buyers .

I was very pleased to think at last we could all work united offering several markets to farmers. Silly me, I thought they had realised Australian farmers needed alternative markets so not to be solely be reliant on live trade. It crossed my mind as well that perhaps because of this senate Inquiry- they may have changed their NO OTHER Business welcome policy. However that was short lived once I contacted AGFORCE as the cattleman's Association asked:

It is important to note I\* did not mention live exports once- I just wanted to arrange guests to Australia to meet with farmers- Here was the response-( I have typed out here a copy of my recollection of message relayed to me:

## **AWB ENQUIRY COWS WITH GUNS MEDIA RELEASE**

### **Desperate cover-up in Iraqi “blood money” saga**

The Australian Wheat Board (AWB) is desperately working to cover up its connections to the controversial live export trade, according to investigations by an animal welfare group. People against Live Exports (PALE) have uncovered evidence that while the AWB was knowingly diverting millions to Saddam Hussein's regime under Iraq's Oil-for-food scheme, it was also secretly raising cash from interests in the live Animal export trade.

PALE founder Wendy Lewthwaite said the scandal was the best kept secret of the Cole inquiry into the AWB.

“The public line is that the Australian Wheat Board sells wheat. They are very keen to keep it quiet that they have also been raising blood money through their connections to the cruel live export trade,” Ms Lewthwaite said.

“I uncovered evidence in 2003 that the AWB had purchased interests in livestock company Landmark a short time after the Cormo Express debacle took place. The profits from this venture likely forms a proportion of the money sent to Iraq.”

Ms Lewthwaite said the AWB and the Cole inquiry had gone out of their way to keep information about AWB's connections to Landmark a secret.

“The public has a right to know the facts about this case,” Ms Lewthwaite said.

“There is a strong public interest in Live Exports and the AWB involvement in live exports is of direct relevance to the current inquiry. It is both immoral and duplicitous for this information to be concealed.”

Ms Lewthwaite said PALE was calling on the government to ensure the Cole inquiry process was transparent and that uncomfortable details about the AWB’s business dealings were not swept under the carpet.

Millions of live sheep, cattle, goats, and other animals endure journeys for up to 3 months from the farm gate to their overseas destinations and eventual very cruel slaughter. Miss Lewthwaite has held meetings with Muslim Leaders of Australia, Malaysian Government officials who advise they do not acquire animals alive for religious purposes and that it is clearly driven by the Government and the department of Trade and Trades.

**The Australian Federation of Islamic Societies (AFIS HKM) ANIMAL WELFARE ORGANIATION** strongly oppose the export of live cattle abroad **and “support the RSPCA process of stunning the cattle and all Animals before halal or non-halal slaughtering.** The process of stunning should be applied to the animal while it is standing on its feet. The intensity of stunning should be such that if the animal is left un-slaughtered it should be able to get up and walk away.



In order to minimize the level of stress and anxiety to the cattle it is imperative that when an animal is being slaughtered the other animals should be isolated and kept away.

**Stunning is the most humane way of making the animals unconscious before slaughtering and it ensures that they suffer the least pain.**

**This method of stunning complies with the States and Federal legislations.**
