

MIKE HOLT SUBMISSION TO THE SENATE INQUIRY:

I, Michael Thomas Holt, an Australian citizen and Vietnam veteran, submit that halal certification is a scam aimed at the Australian people. In effect, it is a religious tax on our food imposed without the permission of the Australian people. This has been done secretly over many years.

We the People have been robbed by this illegal tax racket, and we want our money back if/when it is proved that halal certification truly is a racket. Everyone who has gone grocery shopping since the 1980's when the first halal certificate was issued in Australia should be repaid a lump sum by islamic halal certification companies to compensate us.

It has been proved in Canada that halal certification companies were funneling their ill-gotten gains to terrorist organizations through front organizations. This is documented here:

The islamists often proclaim that halal is good for us because the meat is supposed to be 'clean'. That is arrant nonsense. When an animal is slaughtered without stunning, as required under sharia law, it dies in pain and fear. That produces huge amounts of adrenalin that is pumped into the meat while the heart still beats. This taints the meat, making it tough and bitter tasting. Large amounts of adrenalin and other chemicals produced by the animal's body during slaughter are suspected of increasing the incidence of cancers we now face.

The halal racket, however, goes much deeper than a mere religious tax on our food. It is part of an ongoing onslaught to impose islam on every sector of our society. Hizb is the same organization that recently held a meeting in Sydney and demanded that the sexes be segregated according to islamic sharia law. This is AUSTRALIA, not some misbegotten islamic country. I was particularly angry that the Australians attending this meeting complied with their demands. If I had been there I would have refused to allow this segregation. It is discriminatory and the organizers should have been charged under our Anti-Discrimination Act. Why haven't they already been charged?

We know that halal is just one prong of a concerted attempt to destroy our democracy and impose sharia law on us, as has happened in many countries before. Indonesia was once predominantly Buddhist and Hindu. It is now islamic. The same with Afghanistan, Iran, Iraq, Egypt, and many other nations that have all fallen to the islamic scimitar and been forced to become islamic.

During police raids in Switzerland recently the police found a damning document called "The Project". It laid out a plan for all islamists to follow to wage jihad (war) on the west to subjugate us under islam. We have published this document here:

Hizb ut-Tahrir, the Islamic Council of Australia and its sub-branches in every state, are carrying out activities to the letter of "The Project" (This name sounds familiar, doesn't it? This is just laughable. These youths are merely doing exactly what islam teaches. They weren't "radicalized" within weeks. We have already seen the CIBT scandal and the bank's resulting closure by ASIC. During my investigations of this now-defunct company I came across what looks like its successor, "Crescent Wealth". This company needs to be investigated, as it supplies "international finance"....but to whom? Where does it get the money for these activities? There are many questions that need to be answered about this company.

Senator Bernardi, as you can see from the above, halal is just the tip of the iceberg. I urge you to open up your investigation to cover every aspect of islam's incursions into our nation, including banking, finance, legal, political (how can a Senator swear an Oath of Office on a Koran in a country based on Christian principles?) and socially.
