QUESTION ON NOTICE – JUDE EMMER

I was invited to attend the Senate Committee Hearing in Brisbane on 11 October 2024, to discuss the Aged Care Bill 2024. I was asked a question which I took on notice.

Question – Do you believe that there is potential for greater or lesser impacts in rural, regional and remote Australia in relation to the changes that are contained in this Bill? In particular around the financial viability provisions, whether it be a RAD retention or consumer contribution, do you see that these are going to have an equitable impact across your sector? Or do you see that the impact on smaller rural, regional and remote providers is likely to be less beneficial?

Response – The below information has been sourced from an aged care provider in the UnitingCare Australia network that delivers residential aged care in metropolitan, regional, rural and remote locations.

Four tables show the number of supported residents in a residential home, as well as the number of residents paying Daily Accommodation Payments (DAP) or a Refundable Accommodation Deposit (RAD). The final column shows revenue that home would receive through 2% retention of an average RAD for that facility.

These tables demonstrate the fact that residential homes in regional, rural and remote locations generally have fewer residents, and in some cases no residents, paying a RAD, compared with homes in metropolitan locations. This means that these homes will not retain as much revenue through a RAD retention policy.
