By facilitating smoother travel for Australians, the GEP will enhance business opportunities, cultural exchange, and educational collaborations. This ease of travel will contribute to greater economic and diplomatic engagement, further enriching the Australia-U.S. partnership.

Key Considerations

While we strongly support the Bill, we encourage the Australian Government to ensure transparency and efficiency in implementing the program. Specifically:

• Cost Clarity for Applicants: The costs associated with background checks should be clearly communicated and remain affordable for Australians across all income brackets.

• Privacy Protections: The Bill outlines robust safeguards for personal data collected during background checks. We encourage continued oversight to ensure privacy standards are upheld, and that data transfers to U.S. authorities are limited strictly to eligibility determinations (e.g., "Eligible" or "Not Eligible").
