**COMMUNITY CONSULTATION REPORT:
LAND 121 STAGE 5B FACILITIES PROJECT**

This letter is to inform the Parliamentary Standing Committee on Public Works (PWC) of the nature and extent of community consultations undertaken by the Department of Defence as part of LAND 121 Stage 5B Facilities Project (the Project) works.

The aim of the community consultation adopted by Defence was undertaken with the following objectives:

- ensuring that the community was informed about the project using effective, proven communication channels; and
- ensuring the community had opportunity to raise issues of concern so that wherever feasible, they could be addressed by Defence in its program of works.

The stakeholder and community consultation activities listed below are being delivered in accordance with Defence's comprehensive community engagement strategy for the Projects:

- Advertising Community Consultation sessions in local and state newspapers. A list of the publications and an example of the advertisement are in Annex A.
- Between 23 and 29 January 2020, distributing project newsletters to approximately 50,000 households and businesses via letter box drop to suburbs surrounding Gallipoli Barracks. A copy of the newsletter is in Annex B.
- Inviting key stakeholders to receive a personal briefing about the Project, including State and Federal Members of Parliament, State Departments and Authorities, Local Government and Community Groups. A status of these briefings is in Annex C. An example of the letter of invitation is in Annex D.
- Conducting Community Information Sessions near proposed work locations. The level of attendance and information provided at these sessions is in Annexes E and F.

- Community members were given the opportunity to request further information regarding the Project via email to LAND121Stage5B@jacobs.com. A summary of email correspondence up to 08 April 2020 and key issues raised by the community during the information sessions are detailed in Annex G.
- A community group, called the ‘Gallipoli Precinct Action Group’ (GPAG) has formally put forward a submission to the PWC raising community concerns. The submission is provided in Annex H.

Information regarding the proposed works was generally well received at the community and stakeholder consultations. The Project is not aware of any objections to the proposed works at any of the locations.


Owing to travel restrictions imposed in response to the COVID-19 pandemic, briefings requested by the Federal, State and Local members for Gallipoli Barracks were postponed. All members have requested a briefing once travel restrictions have been lifted.

Defence is continuing to engage with residents surrounding Gallipoli Barracks and the GPAG through the Base Community Liaison Officer. Concerns raised during consultation related to:

- construction noise; and
- the impact of construction traffic accessing Gallipoli Barracks.

A summary of all key points raised by the community during consultation and Defence’s responses are provided in Annex G. Consultation activities are continuing as indicated in Annex C and G.

The community consultations sessions were advertised in local and state newspapers as shown in Annex A. In addition, the project conducted a letterbox drop of leaflets for the works at Gallipoli Barracks as shown in Annex B.

Featherboards were on display at each session to depict project details at both the national and local levels, and flyers made available to attendees. These resources are shown in Annex F.

Three local Defence stakeholders attended the Derwent Barracks community consultation. No local Defence stakeholders attended the Campbell Barracks community consultation, however the project team held a site visit at Campbell Barracks that day to brief local and state members, and this site visit was attended by the Senior Australian Defence Force Officer (SADFO) for Campbell Barracks. Two members of the community attended the Campbell Barracks consultation, in order to understand the project scope and location to assess whether there are any impacts on the local neighborhood. Neither community member raised concerns regarding the proposed works.

Community attendance at the Gallipoli Barracks consultation session was significantly higher with a total of 29 attendees. This strong attendance at the Gallipoli Barracks session is due to the location of the base, the proximity of base boundaries to adjacent households and an active local community group concerned about potentially disruptive activities being undertaken on base. Of the 29 attendees, one was a local Defence base stakeholder.

At each consultation session, attendees were invited to submit comments in writing. The comments received were predominantly enquiries from locals living close to base seeking information on project scope, duration, location and any impact to surrounding streets and residents.





LAND 121 VEHICLES

The vehicles provided by LAND 121 will deliver a networked and integrated capability as part of modernisation of the Australian Defence Force (ADF). They represent a significant increase in capability, replacing multiple vehicle fleets that have been in service since the early 1980s.

To support the introduction into service and subsequent operation of the new vehicle fleet, suitable infrastructure and support facilities are required around Australia. LAND 121 as a project has been in progress for a number of years and is delivering the acquisition component of the vehicles in four phases.

30 different vehicle types are allocated to 473 units across 126 bases in 7 states, comprising 8674 vehicles, 4852 Trailers and 3974 Modules.

Vehicles are categorised as Light / Lightweight; Medium; and Heavy capability vehicles, trailers and modules. Vehicles are split further into protected and unprotected variants.

Allocation is split into two stages, 2A and 2B, with each split further into two phases, 3A/3B and 4/5B respectively.


The LAND 121 Stage 5B Facilities Project will provide facilities for Defence units receiving new vehicles under Phases 4 and 5B of the LAND 121 Project.

LAND 121 PHASE 4

LAND 121 Phase 4 will provide a fleet of vehicles, with companion trailers, for command, liaison, utility and reconnaissance roles. These vehicles will replace around one third of the current Land Rover fleet, with the Protected Mobility Vehicle - Light providing increased force protection in operational environments.

LAND 121 PHASE 5B

Defence will acquire medium and heavy vehicles along with associated modules and trailers under LAND 121 Phase 5B. The Phase 5B fleet will include both protected vehicles (for operational deployment) and unprotected vehicles. These vehicles will replace the current fleet of Unimog, Mack and S-Liner trucks, providing Defence with the capability to undertake field vehicle and trailer tactical training and general logistics roles.



NATIONAL PROJECT

LAND 121 Stage 5B Facilities Project is a multi-phased project providing the Australian Defence Force (ADF) with current-generation, high-capability field vehicles, modules and trailers. Protected (armoured) and unprotected vehicles providing battlefield mobility, logistics support and tactical training will be procure. The key phases of the project to achieve this are:

- Phase 4 - Will provide Protected Mobility Vehicles - Light (PMV-L) with companion trailers for command, liaison, utility and reconnaissance roles.

- Phase 5B - Will provide medium and heavy capability vehicles, together with associated modules and trailers.

The works proposed to be delivered by the LAND 121 Stage 5B Facilities Project provides new facilities to support the introduction, operation and deployment of the ADF's new vehicle fleet. Facilities are required to reduce environmental impacts on the vehicle and its ancillary equipment as well as any vehicle operators engaged in maintenance.

These facilities include new/maintenance facilities, storage, vehicle washing and parking areas, administrative support and facilities to meet various legislative requirements for the operation of vehicles.

The proposed facilities will be delivered at the following Defence locations:

- Gorwent Barracks, Hobart, Tasmania;
- Campbell Barracks, Swanbourne, Western Australia;
- Lavrakk Barracks, Townsville, Queensland (delivered by AFV);
- Puckapunyal Military Area, Victoria (delivered by AFV);
- Robertson Barracks, Palmerston, Northern Territory; and
- Ballito Barracks, Enoggera, South Queensland.

The overall delivery schedule is proposed to commence in the 3rd quarter of 2021 and conclude in the 2nd quarter of 2024.

The delivery programme has been developed to maintain continuity of operations/capability and minimise disruption to the existing Defence facilities.



ROBERTSON BARRACKS WORKS

Robertson Barracks is located approximately 22km from the centre of Darwin close to the suburb of Palmerston. Robertson Barracks has been the home of elements of the 1st Brigade since the mid-1990s with the base being constructed in unit areas over the subsequent period. The base has been operating heavy vehicles including heavy plant and tank transporters along with armoured personnel carriers, ASLAVs and both the Leopard and Abrams MBT for the last decade.

The senior officer in Darwin, Commander 1st Brigade is accommodated in Robertson Barracks.

New and refurbished Simulation Centre training facilities are proposed to integrate people and platforms across live, virtual and constructive applications to deliver enhanced training and preparedness.



GALLIPOLI BARRACKS WORKS

Gallipoli Barracks, Enoggera is one of Australia's largest military bases and the headquarters of the 7th Brigade. Located within the base are Armoured Artillery, Engineering, Signals, Infantry, Medical and other Combat Service Support units.

It was officially established in the early 20th century when the area was used for field training, although the area has been used by military units as far back as the mid-1800s. Since then it has been developed into a modern military base, which is now home to units of the 7th and 11th Brigades, as well as the headquarters of the 1st Division and the 35th Aviation Project.

Brigadi:

The LAND 121 Stage 2A project recently completed a new AdBlue facility within the existing fuel point, a new D-Store, pharmacy store and upgrades to the existing headquarters for 11 CMC, refurbished existing administration facilities for 1D FSB CATR PL, and a new workshop, D-Store, hazardous goods store, fire tank shelter and vehicle compound for 7 CSSB.

The LAND 121 Stage 5B Facilities Project is providing facilities for the 2nd General Health Battalion (2 GHIB) and 1st Signal Regiment (1 SIG REGT). These units will be allocated 148 vehicles as part of the LAND 121 Project.

2 GHIB is a unit of the 17th Combat Service Support Brigade. The battalion provides deployment to provide field medical support for land-based forces. This includes initial wound surgery, resuscitation (surgical resuscitation) and medium to high intensity nursing care in the area of operations.

2 GHIB also provides Role 2 Enhanced and Role 2 Light Maneuvre health support in the deployed environment and to contribute to garrison health support, in order to maintain combat power for use by operational commanders.

1 SIG REGT provides Communication and Information Systems and Combat Service Support to Headquarters 1st Division and the Deployable Joint Force Headquarters in order to meet Command and Control requirements during force preparation and contingency operations.

1 SIG REGT is required to maintain high readiness force elements to ensure it is capable of providing short notice operational support throughout the year.

Key considerations in determining the LAND 121 Facilities solution included the adequacy of existing facilities, spatial requirements of the new vehicles, existing site constraints and the functional and operational relationships between and within units.

The works delivery program is scheduled to commence during the 3rd quarter of 2021 and be completed by the 4th quarter of 2023.



CAMPBELL BARRACKS WORKS

Campbell Barracks is located on the West Coast Highway at Swanbourne. The proposed site contains a number of existing buildings including a workshop, substation and vehicle storage structures located around a transport compound.

The current Campbell Barracks Redevelopment project includes new and refurbished working accommodation and site infrastructure upgrades. Works completed as part of the LAND 121 Stage 2A Project includes the construction of a new loading ramp, weighbridge vehicle wash point and loading ramp.

The Special Air Service Regiment (SASR) is housed at Campbell Barracks. SASR operate a variety of vehicles and equipment including Land 121 medium and light vehicles.

SASR will be allocated 38 vehicles under the LAND 121 Project.

The works delivery program is scheduled to commence during the 3rd quarter of 2021 and be completed by the 2nd quarter of 2024.



DERWENT BARRACKS WORKS

Derwent Barracks is an Australian Army Barracks in the Hobart suburb of Glenorchy, near the Elwick Racecourse and Hobart Showground.

Derwent Barracks is home to the Joint Logistics Unit Victoria – Hobart (JLU V). The unit is part of JLU Bandiana in Victoria and provides logistical support to all Tasmanian Army units, typically delivering requirements for warehousing and maintenance.

The unit will be allocated 8 vehicles under the LAND 121 Project.

The works delivery program is scheduled to commence during the 3rd quarter of 2021 and be completed by the 4th quarter of 2022.

Due to height clearance limitations at the two existing workshop facilities, these facilities are not adequate for the new LAND 121 vehicles. Increasing the overall height of the buildings is not feasible due to extensive structural changes required.

New maintenance facilities are to be provided which address the new heavy vehicle height access requirements of the LAND 121 variants.

Existing Vehicle Shelters will accommodate all of the LAND 121 vehicles comprising 8 new G-Wagon and Medium Unprotected variants.

The proposed facilities will include the following elements:

- a new seven bay vehicle Workshop with associated support, offices, showers, lockers and ablutions facilities;
- a new Fire Tank Shelter and Tank; and
- a new vehicle hardstand to provide vehicle access to the Workshop.
