#### **Question:**

**Senator AYRES:** Was the Prime Minister's office consulted? Mr Gaetjens would probably know the answer to that question. Do you know the answer to that question?

**Mr Reid:** I think the Office of the Prime Minister—

**Senator AYRES:** You 'think'? What do you know about whether or not the Prime Minister's Office was consulted?

**Mr Reid:** I'd have to take that on notice.

**Senator AYRES:** Mr Gaetjens would know, though, wouldn't he? If the Prime Minister's office was consulted, Mr Gaetjens would be the one most likely doing the consulting, wouldn't he?

**CHAIR:** Senator Ayres, the witnesses have taken the question on notice.

**Senator AYRES:** It's a slightly different question, isn't it, about who would be likely to know? Did the Prime Minister's office draft or redraft any part of the submission?

**Mr Reid:** Again, I'd need to take that on notice to have a look at the records.

**Senator AYRES:** Yes. I make the same point—Mr Gaetjens would know. On notice, I'd like the dates on which any draft to the submission was submitted to the Prime Minister's office and the dates on which any comments—including proposed changes—were received by the department.

**Mr Reid:** Certainly, Senator.

#### **Answer:**

A copy of the Department of the Prime Minister and Cabinet's submission was provided to the Prime Minister's Office on 19 September 2021. Comments were received on 20 and 21 September 2021. Mr Gaetjens did not undertake the consultation.

#### **Question:**

**Senator AYRES:** ... how many freedom of information requests seeking national cabinet papers has the department rejected on the basis of the cabinet exemption? How many freedom of information requests seeking national cabinet papers has the department received since the decision in the Patrick case?

#### **Answer:**

In relation to freedom of information requests made to the Department of the Prime Minister and Cabinet seeking National Cabinet material, three such requests have been granted in part and six such requests have been refused in full, on the basis of section 34 of the FOI Act.

Since the decision in *Patrick and Secretary, Department of Prime Minister and Cabinet* (Freedom of Information) [2021] AATA 2719 (5 August 2021) to 27 September 2021, 50 freedom of information requests were received expressly seeking access to National Cabinet material.

#### **Question:**

- How many FOI applications have been made to your Department for National Cabinet documents since the National Cabinet was established? Have they all been refused under s.34?
- How many FOI applications have been made to your Department for National Cabinet documents since Justice White's decision?
- How many current FOI applications to your Department for National Cabinet documents are yet to be determined? Are they being assessed consistently with Justice White's decision?

#### **Answer:**

For the period 13 March 2020 to 27 September 2021, 62 requests for National Cabinet material have been received. They have not all been refused under the Cabinet exemption in section 34 of the *Freedom of Information Act 1982*.

Since the decision in *Patrick and Secretary, Department of Prime Minister and Cabinet (Freedom of Information)* [2021] AATA 2719 (5 August 2021) to 27 September 2021, 50 requests were received expressly seeking access to National Cabinet material.

As at 27 September 2021, 36 requests for National Cabinet material are not finalised. Each is being assessed on a case-by-case basis.

#### **Question:**

- Your submission says that “Maintaining confidentiality over National Cabinet information and discussions is critical to its effective operation.” How do you respond to the criticism from AHRC and the Law Council that qualified exemptions based on public interest are more appropriate than blanket exemptions to protect National Cabinet documents?

#### **Answer:**

The *Freedom of Information 1982* makes provision for exemptions and public interest conditional exemptions. It is open to a decision maker to apply one or more of these exemptions depending on the documents under consideration.

Have all States and Territories agreed to enact changes consistent with Schedule 3?

#### **Answer:**

It is a matter for individual jurisdictions to determine the need for complementary amendments.
