Topic: Extradition process related to Neil Prakash

Question

- 1. Could the Department please provide an update on the status of the extradition process in relation to Neil Prakash? Specifically:
- a. Has the Australian government appealed against the decision by Judge Ismail Deniz in July last year to deny Australia's extradition request?
- b. If so, what is the status of that appeal?
- c. What are anticipated to be the next steps in that extradition process?
- 2. If, having exhausted all rights of appeal, the extradition request fails, what is likely to happen to Mr Prakash at the conclusion of his sentence if:
- a. Fiji refuses to issue Mr Prakash with a passport; or
- b. Fiji refuses to allow Mr Prakash to enter that country?

Answer

- 1.
- a. Australia's extradition request was declined by the Kilis Criminal Court in Turkey in July 2018. Australian authorities understand that Turkish authorities have appealed the decision of the Kilis Criminal Court on behalf of Australia. The appeal was made to the Ankara Supreme Court in September 2018.
- b. We understand that a hearing date for the appeal is yet to be set.
- c. We understand that Australia's extradition request will remain in place until the conclusion of any appeal proceedings and, subject to the outcome of the appeal, the conclusion of the custodial sentence imposed on Mr Prakash in Turkey.
